Sub : Granite Mining Operation in Mouza Tilaboni Plot No. 1114 - F.I.R

We have been granted a mining lease by the State Government over Plot no. 1114, J.L. No. 04, Mouza - Tilaboni, P.S. & Block - Hura, Dist.- Purulia having an area of 11.26 acres for Granite mining operation.

We were given possession of the said plot by the B.L. & L.R.O., Hura on 17-01-2019 in terms of the order of ADM and D.L. & L.R.O. Purulia no. VI/199/86/M/03 dated 10-01-2019.

After completing all the procedures, we started lawful mining operation with our personnel and equipments on the said plot in Mouza, Tilaboni, Plot No. 1114, P.S. & Block, Hura, Dist. - Purulia on 3rd of June, 2022. The said operation was carried on peacefully for three hours and thereafter the operation was wind up for the day.

Our staff and workers were about to return after winding up the operation for that day. Suddenly some persons came from nearby villages and started assaulting, abusing and harassing our staff and one of our directors present there. They even beaten our director Mr. Santosh Sanghai and one of the staff namely Mr. Patit Paban Chakraborty and threatened all of them with dire consequences if we continue or commence again the mining operation on the said plot. They snokhed and damaged the Mobile Phone of our Jcb operator and of Mr. Patit Paban Chakraborty Some of the persons who threatened, beaten and assaulted were :-

They kept our staff and workers hostages for one hour and so and then let them go with the warning that if they come again to start the mining operation on the said plot they would face with dire consequences.

In the circumstances, we request your goodself to take necessary action against the culprits who illegally prevented & obstructed our lawful mining operation on the said plot as well as threatened, beaten and assaulted our staff.

We further request you to give us police protection so that we can start again the mining operation on the said plot in term of the Lease granted by the State Government.

Last but not the least we would also like to mention here that some people of the nearby villages have apprehension that we shall damage the Tilaboni Pahad and which they are opposing. We make it specifically clear that we would never damage the Tilaboni Pahad, instedd we would do the Lawful Granite mining operation on the flat land beside the Tilaboni Pahad.
