Sub: - Complaint against Ashutosh Mahato (29 yrs.) S/O- Prabir Mahato of Vill- Manguria, PO- Manguria- Lalpur, PS- Hura, Dist- Purulia to start a cog case U/S-46A(c) B.E. Act.

Sir,

In producing here with arrested accused namely Ashutosh Mahato (29 yrs.) S/O- Prabir Mahato of Vill- Manguria, PO- Manguria- Lalpur, PS- Hura, Dist- Purulia along with seized Country Spirit bottles DIL SE 10 (Ten) bottles 600 ML each (details of seized articles are mentioned in attached seizure list), I beg to submit that today i.e. on 10.06.2022 at 18.45 hrs. received a credible source information from my reliable source that the above noted accd. person was stoking and selling Country Spirit from his shop at Daldali morh. Accordingly I informed the matter to OC Hura and as per his instruction I PSI Sk Amanur along with force left for work out that information. After reaching to spot at about 19.15 hrs. along with force and held raid in the shop of above noted accd. at Daldali morh under Hura PS against illegal stock and selling of liquor and during the time of raid found that the above noted accused person was stocking and selling country sprit which was kept in his shop at Daldali morh under Hura PS, Dist Purulia. On demand, he failed to produce any valid documents/ License in respect of selling and stocking Country Spirit. Accordingly, I seized all the sealed Country Spirit bottles (details in attached seizure list) after preparing proper seizure list duly signed by the witnesses and labeled sample one bottle. As he committed offence u/s- 46A (C) B.E. Act. So I arrested him u/s- 67 B.E. Act. at 19.45 hrs. after preparing proper Arrest Memo, maintained all formalities regarding arrest and supplied one copy to him . Entire posses completed in between 19.25 hrs. to 19.45 hrs . This is to note here that on seeing police party all public/customers fled away.

Under the above fact circumstances and, I therefore pray that a Cog. Case U/S 46A(c) B.E Act may kindly be started against the arrested accused person namely Ashutosh Mahato (29 yrs.) S/O- Prabir Mahato of Vill- Manguria, PO- Manguria- Lalpur, PS- Hura, Dist- Purulia and arrange for its investigation.
