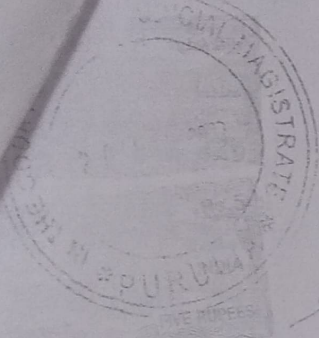

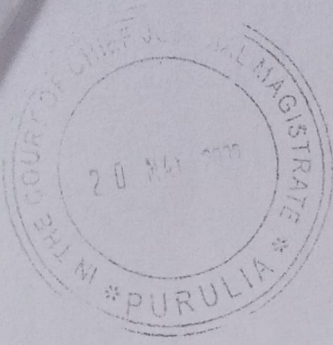

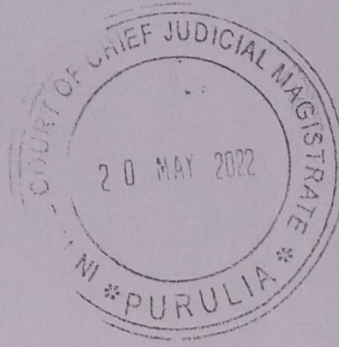

- 1) That the complainant is a petty contractor and is residing at village- Ladhurka, P.S. Hura, Dist- Purulia.
- 2) That the complainant is a bonafide contractor having his valid License and he is doing works in various places including in his own Panchayat.
- 3) That the accused Haripada Mahato also is a bonafide credentials contractor and also use to do various works throughout the District.
- 4) That the said accused Haripada Mahato is known to the complainant for a pretty long time having their friendship.
- 5) That as the accused Haripada Mahato is a credentials contractor he cannot do and supervise all the tendered works and also for his financial stringency have from time to time allotted those jobs to the petty contractors.
- 6) That said accused Haripada Mahato was actually allotted two tender from Government of West Bengal office of the Executive Engineer, (A-I) Purulia (Agri- Irrigation) Division, Belguma, Purulia being Memo no. 432 dated

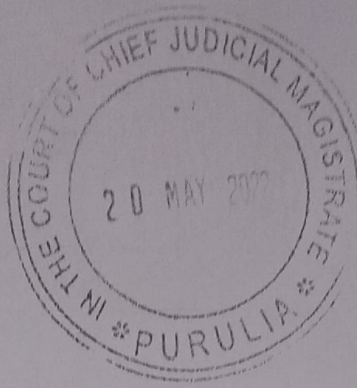
16/08/2021 (work for construction of Adaldi WDS-1 at mouza adaldi, J.L. No. 110, Plot no. 360-363, Block Jhalda-I, Dist- Purulia under WBADMIP 2020-21) and another Tender Memo No. 427 dated 16/08/2021 (Work for construction of Hatimuri WDS 5 at mouza Hatimuri, J.L. No. 55, Plot no. 1746, Block Joypur, District Purulia under WBADMIP 2020-21).

Accordingly the said accused Haripada Mahato requested the complainant to do the said work on his behalf by spending money from the own fund of the complainant. One agreement in between the complainant and the said accused Haripada Mahato was executed before the Notary Public, Purulia wherein it has been agreed by the said accused Haripada Mahato will taken 12% from the tendered amount and accordingly the complainant will get 88% of the said amount.

- 7) That it may be mentioned herein that the accused Haripada Mahato is the contractor and accordingly money will be deposited in his Bank Account after completion of work,

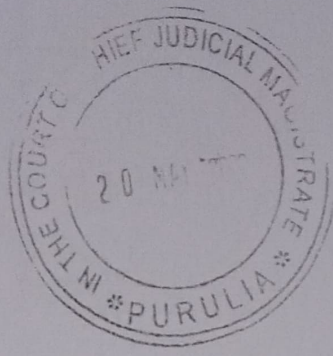

and as and when money will be deposited the said accused Haripada Mahato will pay the complainant of the said agreed amount without any delay.

- 8) That accordingly after completion of work, completion certificate was deposited and final bill was paid accordingly and the money has been deposited in the Account of said accused Haripada Mahato. When the complainant came to learn then the complainant requested to the accused Haripada Mahato to give him the money as per agreement i.e. the 88% which has been deposited in the account of accused Haripada Mahato against those tender work. But the said accused Haripada Mahato without giving the money to the complainant asked him to come one day after another and by that time the complainant learnt that intention of accused Haripada Mahato is otherwise.
- 9) That thereafter, the said accused Haripada Mahato absconded for a pretty long time and the complainant

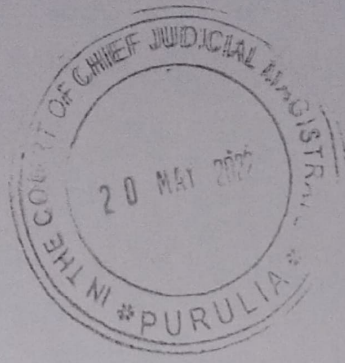

learnt that he took shelter in his father-in-laws house within the district of Medinpur.

- 10) That the complainant also learnt that there are so many persons who are entitled to get money from the said accused Haripada Mahato
- 11) That in such circumstances the said accused Haripada Mahato for his personal gain and loss to the complainant cheated him by not paying the agreed amount against the work tendered.
- 12) That it may be mentioned that during the said work the complainant has paid the payment of labourers as well as other equipments cost borrowed from others and accordingly the complainant is facing financial stringency.
- 13) That the accused person committed various offences punishable under the Indian Penal Code for which he is deserved to be punished under the law.
- 14) That the matter was reported to the Officer-in-charge Hura P.S. against the accused persons but the said Officer-in-charge did not take any legal action against the accused
