Subject:- First Information Report regarding Obstruction of Public Servant in Discharging his duties and Misbehaving with them with abusive and slung language against 1. Rakesh Mahato, S/o: Ghanashyam Mahato; 2. Ajoy Mahato, S/o: Sarbeshwar Mahato; 3. Janik lal Mahato, S/o: Bhairab Chandra Mahato.

Dear Sir,

With the above cited subject this is to inform you that on 16.06.2022 around 1:30 PM our LT mobile van along with LT Line staff's was obstructed by few people of the village Kulabahal, the same people also obstructed the vehicle of the undersigned, Divisional Engineer and Station Manager of Hura CCC Sri. Shyamsunder Murmu, (i.e., Myself) with Me and 3 No's Technical staff (1. Sunil Kumar Roy, Sr. TSH; 2. Bhudev Chandra Mahato, Sr. TSH; 3. Dharapati Mahato, Sr. TSH).

LT mobile van staff went there to attend 2 No's Docket Call vide Docket No: 49393592 & 49391696. After attending the dockets and fixing problems when they were ready to leave the site 3 person's approached them and starts misbehaving with abusive language.

I, Station Manager of Hura CCC along with 3 Technical Staff was surveying the nearby site for preventive breakdown maintenance in a separate vehicle (Office Vehicle). When we are about to pass through the Hari Mandir of the village we saw LT mobile van staffs were being abused verbally and mentally by some local persons. I have stopped the vehicle in the spot to handle the situation.

After spotting me the main 3 culprit namely 1. Rakesh Mahato, S/o: Ghanashyam Mahato; 2. Ajoy Mahato, S/o: Sarbeshwar Mahato; 3. Janik lal Mahato, S/o: Bhairab Chandra Mahato; (Picture Enclosed) Starts misbehaving with me and my subordinate staffs with abusive language and harassed us mentally with slung language.

At around 3:30 PM Police came to the site and controlled the situation and at the end at around 4 PM they have released the vehicles with all the staffs. Due to such type of humiliating behavior by the above mentioned Persons, Our technical staffs has been de-motivated and it will be difficult for us to Discharge the duty in future. So that It is requested you to treat this letter as F.I.R.

This is for your kind information and taking necessary action please.
