Sub:-Request for lodging F.I.R. against arrested accused person Pintu Sing (40 yrs.) S/O-Shree Sing of Vill- Romi, PO+PS - Itkhor, Dist-Chatra, Jharkhand driver of vehicle No. NL01AB-3127 (Trailer).

Sir,

In producing herewith arrested accused Pintu Sing (40 yrs.) S/O-Shree Sing of Vill- Romi, PO+PS - Itkhor, Dist-Chatra, Jharkhand along with seized one Trailer having registration No NL01AB-3127, I beg to report that today on 17.06.2022 I ASI Amal Kr. Pati along with C/1580-Alam Ansary and C/330 Banamali Soren and C/1450 Uttam Mahapatra all of Hura PS were performing mobile duty vide Hura PS C.C No - 1340/22 dtd. 17.06.2022 and Ref: Hura PS GDE No. - 717 Dtd. 17.06.2022 while we reached at Rakhera More under Hura PS area at about 10:35 hrs. We found one Trailer having Registration No NL01AB-3127 was coming from Bankura side towards Hura side with rash and negligently. We tried to stop him but the driver of the said vehicle named noted above was trying to escape the place dangerously, there was every possibility of loss/ serious injury of nearby public due to his such driving. After a hot chase we could be able to stop him at Bishpuria More under Hura PS, Purulia and found the said vehicle partly damaged road divider at Bishpuria more. On being asked, he stated his name and address as noted above, but unable to give any satisfactory account for his such rush and negligent driving which may cause endanger to human life. On demand he produced all documents in respect of the said vehicle. Accordingly, I seized the same by preparing seizure list (details are mentioned in the attached seizure list) with a view to prosecute him U/S 279/427 IPC and 184 MV Act 1988. The whole process of seizure was completed in between 11:15 hrs and 11:45 hrs. I also arrested driver of the said vehicle as he violated sec 279/427 IPC and 184 MV Act in presence of Police party. His family member was also informed over cell phone about the ground of arrest.

Hence I pray that a specific case U/S 279/427 IPC and 184 MV Act 1988 may kindly be initiated against accused Pintu Sing (40 yrs.) S/O-Shree Sing of Vill- Romi, PO+PS - Itkhor, Dist-Chatra, Jharkhand, driver of vehicle No. NL01AB 3127 (Trailer) and arrange its investigation.
