In producing herewith one arrested accused person namely Parikhit Mahato (33) S/O Rohin Mahato of Vill.- Kashidih, PO-Khamar, PS-Jhalda, Dist.- Purulia under arrest along with seized articles as per seizer list i.e. (i) 10 (ten) Ltrs. ID Liquor (Cholai) in a Plastic Jarican (ii) 18 pieces of plastic glass under proper seizure with label.

I ASI Khageswar Kumar of Jhalda PS hereby lodged a written complaint against the above noted accused person to the effect that today (10/06/2022) myself along with C/04-Abadut Kumar, C/1207-Tarit Kr. Majhi, HG/1636-Harekrishna Ghosh, HG/1681-Manmotha Kumar all of Jhalda PS were performing anti crime evening mobile duty (This refers to Jhalda PS CC No. 1558/22 dated 10/06/2022 and GDE No. 451 dated 10/06/2022. During evening mobile duty at about 18:05 hrs I received a credible source information that the above noted accused person was selling ID Liquor (Cholai) illegally at Kashidih village in his shop under this PS. On receipt such information I immediately informed the matter to you and as per your kind direction I along with force proceeded to work out the information. At 18:55 hrs we reached at Kashidih village and my source shown the person from a distance who was selling the liquors there. We immediately reached there and surrounded them, but other people who were assembled there to purchase liquor, on seeing Police Party managed to flee away from the spot. On searched (i) 10 (ten) Ltrs. ID Liquor (Cholai) in a Plastic Jarican (ii) 18 pieces of plastic glass were found there. On demand he failed to produce any license / authority of the said liquors. On interrogation he also made incoherent statement regarding possession of said liquors and told that he is usually selling the same to the villagers illegally. So, finding no any other alternative I seized the above noted articles from the possession of the accused person and labeled, duly singed by the accused person & witnesses in between 19:15 hrs to 19:35 hrs in which 500 ML of ID Liquor (Cholai) in a bottle from mother sample were kept as sample with label. During interrogation he confessed his guilt as such I arrested him at 19:40 hrs after observing all the formalities as per law issuing memo of arrest as the accused person is liable for prosecution U/S-46A (c) of the Bengal Excise Act 1909.

I therefore pray that a specific Case may kindly be started against the accused person namely Parikhit Mahato (33) S/O Rohin Mahato of Vill.- Kashidih, PO-Khamar, PS-Jhalda, Dist.- Purulia U/S-46A (c) of the Bengal Excise Act 1909.
