I, San Arundhanu Mahato, S/O Late Bhagirathi Mahato of vill. Mosima, P.S. Thaldia, Dist - Purulia, respectfully want to draw your kind attention that on 12/13-06-2022 last night at approx one P.M. Some unknown people covered their head and face entered through back door of my residence. The number of people perhaps 6-7 who directly came at my bedroom of 1st floor and asked for "Cash" "Cash" "Cash" saying "Haste" saying "Haste" they show Pistol and tied my hands including my body and taking me out from bedroom including my mom and sister escorting two people and keep us in a closed room. Then they went other two bedroom and searching for Cash and locked key. When they didn't get any key they they broke two aluminium with a help of crow-bar. They took out cash money approx Eight to twelve lakhs including a bulk amount of Gold jewelry with attached in a list with this application. The whole operation took time likely 35-40 minutes. I also let you know, out of Eight CC Camera destroyed few cameras, the approx age of that doesn't gang perhaps like 25 years but one guys of them in between 45-50 years. They are talking each other and with us in a regional language by mixing bangali and hindi. All cash and gold ornaments including the boxes and valuable documents carried in a red colour medical company's Sode bag.
