This is to report that Plot No: 7675 classified as "Danga" area 1.07 acres and as per the report of the B.L. & L.R.O., Jhalda-I dated 23/05/2022 (copy enclosed), a water body, is being filled up by the recorded owners (copy of the record also enclosed). Yesterday, i.e. on 13/06/2022, again an enquiry was conducted by the 02 (two) S.A.E.s of this Office (copy enclosed) wherefrom it is revealed, that Plot No: 7675 is being filled up, despite warning from the 02 (two) S.A.E.s.

Further, a notice to stop the work was issued from this end to i) Sri Rana Singhdeo, S/o. Late Ashok Singhdeo, ii) Sri Suryaditya Singhdeo, S/o. Sri Joy Kumar Singhdeo and iii) Sri. Somyaditya Singhdeo, S/o. Sri. Joy Kumar Singhdeo, all of Ward No: 1, Jhalda. the recorded owners, a copy of which was also endorsed to you, but they refused to accept the notice and continued the filling work with the help of J.C.B.s and tractors.

You are therefore requested to take appropriate and needful action as per law prevailing against the violators of law, as per the provisions of Section 447/120B of the IPC and read with Section 4C/4D of the West Bengal Land Reforms Act, 1955 alongwith Section 6(3) of Chapter II of West Bengal Inland Fisheries Act, 1984 and Section 17 A of the West Bengal Inland Fisheries Act, 1984.

Your early action in this regard will be highly solicited.
