

Sir,

I. SI Suit das along with force return to PS and brought under seizure One tractor without number plate having Engine No- P335-07562 and Chassis No- 04193521343 attached with trolley loaded with sand (approx 100 cft). The fact in brief is that today (03.06.2022) I along with force namely i) C/1207 Tarit Kr. Majhi ii) C/1284 Pratapaditya Majhi (iii) NVF/778 Samir Kr. Mahato (iv) HG/1636 Harekrishna Ghosh were performing evening duty at Jhalda PS area vide Jhalda PS GDE No- 124 Dated- 03/06/2022 in consonance with Jhalda PS CC No- 1491/22 Dated- 03/06/2022. During my evening mobile duty I received a credible source information that one Tractor was lifting & carrying sand illegally and coming from Shyamnagar Ghat which is situated on Subarnarekha River at Jharkhand Purulia Border & coming towards Jhalda side. Subsequently, I informed you and as per your order, I placed Naka at Gokulnagar more to work out this tip off and started Naka Checking after proper placing guard rail on the road. Thereafter I saw the one tractor were proceeding towards Birsha more. Consequently, we intercepted the said Tractors at Naka checking point at about 21:15 hrs and found that the vehicle as well as goods as identical as I received prior information. But seeing the Police, driver of Tractor fled away leaving the Tractor on road before Naka checking point. We tried to apprehend him but failed. We waited for reasonable time but none came to spot. It was ascertained that the driver of the tractor loaded the said sand in cahoots with the owner of the vehicle by illegal means for selling the same to make profit by dishonestly and they had been running a clandestine business. So it is reasonable to belief that he in cahoots with the owner of the vehicle procured the said sand from Subarnarekha River at Shyamnagar Ghat by fraudulently means or theft by any means for transporting the same to run clandestine business. Ergo I, seized the vehicle One tractor without number plate having Engine No- P335-07562 and Chassis No- 04193521343 attached with trolley loaded with sand (approx 100 cft). under proper seizure list in presence of witnesses duly signed by them. Thereafter, I brought the said tractor to Jhalda PS compound.

Under the above facts and circumstances kindly take lawful action against the Owner & driver of the said vehicle as they committed offence U/S 379/411/414/120B of the IPC & 21 (4) Mines and Minerals (R&D) Act-1957.
