In producing here with O1(One) arrested accused person namely Ashok Biswas (35) S/O Satish Biswas of Mining Colony, Near Niyamatpur, PS- Kulti, Dist- Paschim Burdwan and along with 01 (one) truck having registration No- WB37E 1948 loaded with 180 bags of PDS wheat (each bag containing 50 kg). The fact in brief is that today (06.06.2022) I along with force namely C/1496-Subal Ch. Mahato ii) C/1284-Pratapaditya Majhi III) NVF/778-Samir Mahato iv) HG/1772-Fatik Ch. Kumar was performing evening mobile duty in PS area vide Jhalda P.S. GDE No- 259 Dated- 06/06/2022 in consonance with [halda PS CC No- 1515/22 Dated- 06/06/2022. During my evening mobile duty I received credible source information that one Truck loaded with huge number of PDS wheat coming from Ihalda town side towards Purulia. Subsequently, I informed you and as per your gracious order, I placed Naka at Naya more to work out this tip off and started Naka Checking after proper placing guard rail on the road. Thereafter I saw the one Truck was proceeding towards Purulia. Consequently, we intercepted the said Truck at before Naka checking point at about 18:05 hrs and found that the vehicle as well as goods as identical as I received prior information. But seeing the Police Party driver who was on that vehicle (Truck) started to flee away. After hot chase we managed to apprehend him. On asking he stated his name and address is Ashok Biswas (35) S/O Satish Biswas of Mining Colony, Near Niyamatpur, PS- Kulti, Dist- Paschim Burdwan and on interrogation he also confessed that he is the driver of the sald truck having registration no- WB37E 1948. On demand, he failed to produce any papers in respect of the said Truck loaded with huge number of PDS wheat which falls under the essential commodities. During interrogation, he confessed that he along with owner of the said truck have been running a clandestine business of PDS wheat (essential commodities) by illegal means for selling the same to make profit dishonestly with help of one Joy Kumar Bhagat Of Jhalda. Who procured the PDS wheats (Atta) by illegal means from other ration dealers violating the provision laid down in para 7 of rule 3 West Bengal as well as essential commodity (X) Act 1955. . So it is reasoned to belief that they procured the said PDS wheat for transporting the same to run clandestine business. Ergo I, seized the vehicle 01 (one) truck having registration No- WB37E 1948 loaded with 180 bags of PDS wheat (each bag containing 50 kg) under proper seixure list in presence of available witnesses duly signed by them and arrested him under proper arrest memo and informed him the ground of arrest. Thereafter, I brought the said truck to Ihalda PS compound.

Under the above facts and circumstances kindly take lawful action against the driver & owner of the said vehicles and one Joy Kumar Bhagat of Jhalda as they committed an offence U/S 379/411/414/120B of the IPC & 7 (I)(a)(ii) of E.C (X) of Act 1955.
