Sir,

In producing here with 01 (One) arrested accused person namely Sadhu Gope (30) S/O Shaktipada Gope of Vill- Gowaladih, PO-Jidararu, PS-Kotshila, Dist- Purulia and along with 01(one) seized Tractor having registration no- WB55A 5988 is attached with sand loaded trolley (approx 100 cft). The fact in brief is that today (07.06.2022) I along with force namely i) RM/1463 Bikram Lama (ii) RM/1472 Naresh Darjee were performing Day mobile duty in PS area vide Jhalda P.S. GDE No- 291 Dated- 07/06/2022 in consonance with Jhalda PS CC No- 1520/22 Dated- 07/06/2022. During my Day mobile duty I received credible source information that one Tractor was lifting & carrying sand illegally and coming from Shyamnagar ghat towards Baragram Bagan. Subsequently, I informed you and as per your gracious order, I placed Naka at Jhalda New PS Bortol to work out this tip off and started Naka Checking after proper placing guard rail on the road. Thereafter I saw the one Tractor was proceeding towards Bargram Bagan. Consequently, we intercepted the said Tractor at before Naka checking point at about 13:15 hrs and found that the vehicle as well as goods as identical as I received prior information. But seeing the Police Party driver who was on that vehicle (Tractor) started to flee away. After hot chase we managed to apprehend him. On asking he stated his name and address is Sadhu Gope (30) S/O Shaktipada Gope of Vill- Gowaladih, PO-Jidararu, PS-Kotshila, Dist- Purulia and on interrogation he also confessed that he is the driver of the said tractor having registration no- WB55A 5988. On demand, he failed to produce any papers in respect of the said Tractor which is attached with Trolley as well as loaded sand though sufficient time was given. During interrogation, the he confessed that he along with owner of the vehicle have been running a clandestine business of sand by illegal means for selling the same to make profit dishonestly. So it is reasoned to belief that they procured the said sand from Shyamnagar Ghat of Subarnarekha River by fraudulently means or theft by any means for transporting the same to run clandestine business. Ergo I, seized the vehicle 01 (one) tractor having registration No- WB55A 5988 is attached with sand loaded trolley (approx 100 cft) under proper seizure list in presence of available witnesses duly signed by them and arrested him under proper arrest memo and informed him the ground of arrest. Thereafter, I brought the said tractor to Jhalda PS compound.

Under the above facts and circumstances kindly take lawful action against the driver Sadhu Gope (30) S/O Shaktipada Gope of Vill- Gowaladih, PO-Jidararu, PS-Kotshila, Dist- Purulia and owner of the said vehicles as they committed an offence U/S 379/411/414/120B of the IPC & 21 (4) Mines and Minerals (R&D) Act-1957.


