I do hereby lodge complaint empowered by enabling the electricity act 2003 subsequently the amendment act 2007 to the effect that Phatik Mahato, S/O-Malinda Mahato (Con_Id-242228699, Meter No-B1515574) of village-Jhalmamra, P.O-Chapaitard P.S- Joypur , Dist- Purulia has committed theft of electricity U/S 135(1) (b) of electricity act 2003 subsequently amendment act 2007.

On 01.06.2022 at about 12.35 P.M . I Sri Raushan Kumar, Station Manager, Joypur CCC along with 01.Ganesh Mahato, Gr1 TSH, Joypur CCC , 02.Shibaram Mahato, Hg.TSH, Joypur CCC entered the premises of Phatik Mahato, S/O-Malinda Mahato (Con_Id-242228699, Meter No-B1515574) of village-Jhalmamra, P.O-Chapaitard P.S- Joypur , Dist- Purulia and found Phatik Mahato, S/O-Malinda Mahato was enjoying electricity unauthorizedly drawing power from the incoming service line of WBSEDCL through White colour cable (2.5 sq mm) by means meter bypassing to his domestic premises and connected load found 0.2 KW. As Phatik Mahato, S/O-Malinda Mahato committed theft of electric power. So, I seized the following articles after preparing the seizer list in presence of 01.Ganesh Mahato Gr1 TSH, Joypur CCC , 02.Shibaram Mahato, Hg.TSH, Joypur CCC. The inspection team left the premises at 12.55 P.M.
