With due respect I SI Dibakar Kuiri, beg to submit before you that on 10/06/2022 at about 08:35 hrs while myself along with NVF/-1011 Ishan Mandal, NVF/-817 Bhubaneswar Mahato were performing Special Drive (MV Checking) duty vide Joypur PS CC No-2317/22 Dated-10/06/2022 at Dumurdih More on Purulia-Ranchi Road (SH-4A). I found one Motor Cycle was coming from Jhalda side towards Purulia with Driving Dangerously and rush negligently with excessive over speed. Police personnel of Naka party in proper Police uniform raised hand and directed him to stop the Motor Cycle but said Motor Cycle rider violating the Police Signal and endangering the human life rush and negligently driving the Motor Cycle which may cause any time accident to the road user. After long chase we can able to apprehend him at Dumurdih More. On interrogation he made incoherent statement at different time.
