Sub: Prayer for starting a specific case against one Soumen Dutta (21 yrs) S/o-Uttam Dutta PS-Shivmandir Silidih, PS-Silli, Dist-Ranchi State-Jharkhand (Motor Cycle Rider having Regd. No- JH01DR-2831).

Respected Sir,

With due respect I SI Dibakar Kuiri, beg to submit before you that on 10/06/2022 at about 08:35 hrs while myself along with NVF/-1011 Ishan Mandal, NVF/-817 Bhubaneswar Mahato were performing Special Drive (MV Checking) duty vide Joypur PS CC No-2317/22 Dated-10/06/2022 at Dumurdih More on Purulia-Ranchi Road (SH-4A). I found one Motor Cycle was coming from Jhalda side towards Purulia with Driving Dangerously and rush negligently with excessive over speed. Police personnel of Naka party in proper Police uniform raised hand and directed him to stop the Motor Cycle but said Motor Cycle rider violating the Police Signal and endangering the human life rush and negligently driving the Motor Cycle which may cause any time accident to the road user. After long chase we can able to apprehend him at Dumurdih More. On interrogation he made incoherent statement at different time. He disclosed his identity as Soumen Dutta (21 yrs) S/o-Uttam Dutta PS-Shivmandir Silidih, PS-Silli, Dist-Ranchi State-Jharkhand.

Hence he violated the provision of Section 279 IPC & R/W Section-184 MV Act. So I seized the Motor Cycle having Regd. No- JH01DR-2831 at 12:15 hrs to 12:30 hrs under proper seizure list duly signed by the witnesses and arrested the offending rider namely Soumen Dutta (21 yrs) S/o-Uttam Dutta PS-Shivmandir Silidih, PS-Silli, Dist-Ranchi State-Jharkhand at 12:40 hrs after observing all formalities and explained the ground of arrest, issued memo of arrest. As the offence is bailble hence accused rider namely Soumen Dutta was released on bail.

So I pray specific case may kindly be registered against the accused namely Soumen Dutta (21 yrs) S/o-Uttam Dutta PS-Shivmandir Silidih, PS-Silli, Dist-Ranchi State-Jharkhand (Motor Cycle Rider having Regd. No-JH01DR-2831) for committing offence U/S-279 IPC & R/W Section-181/184 MV. Act.
