With due respect I SI Prabir Kumar Dey, beg to submit before you that on 10/06/2022 at about 16:05 hrs while myself along with NVF/-1011 Ishan Mandal, NVF/-817 Bhubaneswar Mahato were performing Special Mobile-II duty vide Joypur PS CC No-2320/22 Dated-10/06/2022 in-front of Parichay Bhavan, Joypur on Purulia-Ranchi Road (SH-4A). I found one Motor Cycle was coming from Purulia side towards Jhalda with Driving Dangerously and rush negligently with excessive over speed. Police personnel of Naka party in proper Police uniform raised hand and directed him to stop the Motor Cycle but said Motor Cycle rider violating the Police Signal and endangering the human life rush and negligently driving the Motor Cycle without helmet which may cause any time accident to the road user. Somehow we can able to apprehend him in-front of Parichay Bhavan Joypur. On interrogation he made incoherent statement at different time.
