Sub: Prayer for starting a specific case against one Vikash Kumar Uranw (24 yrs) S/o-Umesh Uranw of Vill-Alokdihi tola Barshabad PS-Pindrajora Dist-Bokaro State-Jharkhand Motor Cycle Rider having Regd. No- JH10W5789 Hero Splendar+ Coloured Black, Silver and Blue combination.

Respected Sir,

With due respect I SI Prabir Kumar Dey, beg to submit before you that on 10/06/2022 at about 16:05 hrs while myself along with NVF/-1011 Ishan Mandal, NVF/-817 Bhubaneswar Mahato were performing Special Mobile-II duty vide Joypur PS CC No-2320/22 Dated-10/06/2022 in-front of Parichay Bhavan, Joypur on Purulia-Ranchi Road (SH-4A). I found one Motor Cycle was coming from Purulia side towards Jhalda with Driving Dangerously and rush negligently with excessive over speed. Police personnel of Naka party in proper Police uniform raised hand and directed him to stop the Motor Cycle but said Motor Cycle rider violating the Police Signal and endangering the human life rush and negligently driving the Motor Cycle without helmet which may cause any time accident to the road user. Somehow we can able to apprehend him in-front of Parichay Bhavan Joypur. On interrogation he made incoherent statement at different time. He disclosed his identity as Vikash Kumar Uranw (24 yrs) S/o-Umesh Uranw of Vill-Alokdihi tola Barshabad PS-Pindrajora Dist-Bokaro State-Jharkhand.

Hence he violated the provision of Section 279 IPC & R/W Section-184 MV Act. So I seized the Motor Cycle having Regd. No- JH10W5789 Hero Honda Splendar+ at 16:45 hrs to 17:05 hrs under proper seizure list duly signed by the witnesses and arrested the offending rider namely Vikash Kumar Uranw (24 yrs) S/o-Umesh Uranw of Vill-Alokdihi tola Barshabad PS-Pindrajora Dist-Bokaro State-Jharkhand at 17:10 hrs after observing all formalities and explained the ground of arrest, issued memo of arrest. As the offence is bailable hence accused rider namely Vikash Kumar Uranw was released on bail.

So I pray a specific case may kindly be registered against the accused namely Vikash Kumar Uranw (24 yrs) S/o-Umesh Uranw of Vill-Alokdihi tola Barshabad PS-Pindrajora Dist-Bokaro State-Jharkhand (Motor Cycle Rider having Regd. No- JH10W5789 Hero Honda Splendar+) for committing offence U/S-279 IPC & R/W Section-181/184 MV. Act
