On being asked he disclosed his name and address as noted above. On interrogation he stated that he was selling Illicit liquor to the local people in the area. On demand he failed to produce any valid documents in respect of selling such illicit liquor. So it is reasonable to believe that he was selling the Id liquor illegally without any documents. So I seized the same under proper seizure list in between 18:15 hrs to 18:45 hrs & label duly signed by him and other available witness.
