Sir,

In producing herewith 01 (one) arrested accused person Fichiya Kumar (36 yrs) S/o-Ajit Kumar of Vill-Barabendya PS-Joypur Dist- Purulia, under arrest along with seized articles as per seizer list i.e. (1) 08 (eight) bottle of country spirit each of 600 ml styled as "DILKHUSH" (2) 05 (five) liter illicit liquor under proper seizure with label.

I SI Manas Kumar Panda of Joypur PS hereby lodged a written complaint against the above noted arrested accused person, to the effect that on today (10/06/2022) at about 15:45 hrs when myself along with C/-516 Chnadra Shekhar Mahato, C/-1358 Sanjib Patra C/-1387 Prabir Kumar Mishra of Joypur PS were performing evening mobile duty vide Joypur PS CC No-2321 Date-10/06/2022, as per my source information I reached in the shop of Fichiya Kumar S/o-Ajit Kumar of Vill-Barabendya PS-Joypur Dist- Purulia under Joypur PS and found that the above noted accused person selling illicit & country spirit liquor in the shop. On seeing Police person, he conceal his presence at that place, but on searching we able to trace out him and also to found that (1) 08 (eight) bottle of country spirit each of 600 ml styled as "DILKHUSH" (2) 05 (five) liter illicit liquor which was kept in a white colour Jarican at his shop. On being asked he disclosed his name and address as noted above. On interrogation he stated that he was selling Illicit liquor to the local people in the area. On demand he failed to produce any valid documents in respect of selling such illicit liquor. So it is reasonable to believe that he was selling the Id liquor illegally without any documents. So I seized the same under proper seizure list in between 18:15 hrs to 18:45 hrs & label duly signed by him and other available witness.

During further interrogation he confessed his guilt as such I arrested him today 10/06/2022 at 19:05 hrs as the accused person is liable for prosecution U/S-46A (c) of the Bengal Excise Act 1909.

I therefore pray that a specific case may kindly be started against the accused person namely Fichiya Kumar (36 yrs) S/o-Ajit Kumar of Vill-Barabendya PS-Joypur Dist- Purulia U/S-46A (c) of the Bengal Excise Act 1909.
