I SI Dibakar Kuiri of Joypur PS hereby lodged a written complaint against the above noted arrested accused person, to the effect that on today (10/06/2022) at about 17:05 hrs when myself along with C/-3007 Amit Rajak, JC/-1575 Uttam Kumar Mandal both of Joypur PS were performing special mobile duty vide Joypur PS CC No-2323 Date-10/06/2022, as per my source information I reached at Parga more under Joypur PS and found that the above noted accused person selling illicit liquor (Mohula) in the house of Mukesh Mahato S/o-Nitai Mahato of Vill-Parga PS-Joypur Dist-Purulia. On seeing Police person, he conceal his presence at that place, but on searching we able to trace out him and also to found that 20 (twenty) liter of Illicit Liquor (locally known as Mohulla) which was kept in a two white colour Jarican at his house. On being asked he disclosed his name and address as noted above. On interrogation he stated that he was selling Illicit liquor to the local people in the area. On demand he failed to produce any valid documents in respect of selling such illicit liquor. So it is reasonable to believe that he was selling the Id liquor (Mohula) illegally without any documents. So I seized the same under proper seizure list in between 18:05 hrs to 18:15 hrs & label duly signed by him and other available witness after taking 300 ML as sample in a separate bottle from the Jarican.

During further interrogation he confessed his guilt as such I arrested him today 10/06/2022 at 18:25 hrs as the accused person is liable for prosecution U/S-46A (c) of the Bengal Excise Act 1909.

I therefore pray that a specific case may kindly be started against the accused person namely Mukesh Mahato (25 yrs) S/o-Nitai Mahato of Vill-Parga PS-Joypur Dist- Purulia U/S-46A (c) of the Bengal Excise Act 1909.
