In producing herewith one arrested accused person namely Jhantu Mahato (28 yrs) S/o- Late Upashi Mahato of Vill-Bartard PS-Joypur, Dist-Purulia under arrest along with seized articles as per seizer list i.e. 10 (ten) bottles country spirit "DIL KUSH" strength measuring 600 ML each bottles out of which one bottle taken as sample under proper seizure with label.

I SI Dibakar Kuiri of Joypur PS hereby lodged a written complaint against the above noted arrested accused person to the effect that on today 24/06/2022 at about 15:45 hrs when myself along with C/-1356 Rajib Kundu, C/-894 Dhanajoy Mandal & C/-1358 Sanjib Patra were performed evening mobile duty vide Joypur PS C.C. No-2506/22 as per my source information I reached at Bartard Haat in the Hotel of Jhantu Mahato under Joypur PS and found that the above noted accused person selling country spirit "DIL KUSH" in the hotel. On seeing Police persons, he concealed his presence at that hotel, but on searching we able to trace out him and also to found that 10 (ten) bottles of country spirit "DIL KHUSH" which was kept conceal in this hotel. On being asked he disclosed his name and address as noted above. On interrogation he stated that he was selling country spirit to the local people in Bartatrd area after collecting from other side but on demand he failed to produce any valid documents in respect of selling such country sprit. So it is reasonable to believe that he was selling the Id liquor illegally without any documents. So I seized the same under proper seizure list in between 17:25 hrs to 17:45 hrs & label duly signed by him and other available witness after taking 01 bottles of DIL KUSH as sample out of 10 (ten) of DIL KHUSH each bottle 600 ML.

During further interrogation he confessed his guilt as such I arrested him today 24/06/2022 at 17:55 hrs as the accused person is liable for prosecution U/S-46A (c) of the Bengal Excise Act 1909.

I therefore pray that a specific case may kindly be started against the accused person namely Jhantu Mahato (28 yrs) S/o- Late Upashi Mahato of Vill-Bartard PS-Joypur, Dist-Purulia, U/S-46A (c) of the Bengal Excise Act 1909.
