Sir,

I, ASI Uttam Gorain of Kenda PS, Dist- Purulia producing herewith one arrested accused person namely Gulanda Saren (52 yrs), S/o-Lt. Ravan Saren of Vill-Punura, P.S – Kenda, Dist- Purulia with seized articles i.e.1) one white colour jarican containing approx 14 Ltrs. ID Liquor 2) 05 pcs plastic glasses (3) Approx 375 ml ID liquor as sample which was collected from seized articles from Sl. No-01 & kept in a bottle which were seized under proper seizure list.

I beg to submit that today (10-06-2022) during evening Mobile duty acting of a secret source information myself along with C/ 346 Shaktipada Rajak, C/181 Rabban Sekh and HG/1926 Bidhan Tantubai all are of Kenda PS conducted raid in the House of accused person Gulanda Saren at about 19.15 hrs and found that he was keeping and selling of ID liquor at his House to the others. Seeing the Police party, all customers fled way but we managed to apprehended the above noted accused person. On being asked he failed to produce any valid licence /documents in respect of storing and selling of ID liquor. As such I seized 1) one white colour jarican containing approx 14 Ltrs. ID Liquor 2) 05 pcs plastic glasses (3) Approx 375 ml ID liquor as sample which was collected from seized articles from Sl No-01 & kept in a bottle which were seized under proper seizure list in presence of witnesses and duly signed by them as well as accused person and also arrested the above noted accused person after informing him the ground of arrest and after observing all legal formalities. The seized articles were properly sealed and labelled in presence of witnesses. I also arranged to inform his family member about his arrest by police.

Under the above fact and circumstances, I therefore pray that a specific case may kindly be start against Gulanda Saren (52 yrs), S/o-Lt. Ravan Saren of Vill-Punura, P.S – Kenda, Dist- Purulia under proper section of law.
