Sub: - To lodge FIR against owner and driver of Mahindra B275DI, Bhumi Putra (Red Colour) having Rag. No- WB55A/6502 with trolley (without number) sand loaded (100 cft),

Sir,

In producing herewith one Tractor fitted with approx 100cft sand loaded Trolley as per seizure list, having Reg. No- WB 55A/6502 of the engine. I, A.S.I. Anirban Banerjee along with C/1055 Shantimoy Samanta and C/1316 Ujjwal Mandal Vide Manbazer P.S C.C No 2032/22 and GDE No- 253 dt- 07.06.2022 was engaged for evening mobile duty. Then at 18:05 hrs received a credible source information that the above noted vehicle (Tractor) is lifting sand illegally at Nadiha river bed at village- Nadiha under PS- Manbazar, Dist- Purulia. Subsequently myself along with force moved to the spot. We kept our vehicle concealed and moved towards the river bed on foot. Seeing the police party, those persons who were loading sand, fled away from the spot leaving the sand loaded tractor. We rushed and detained the said tractor. We searched the said tractor (Reg. No WB 55A/6502) and found that the tractor is loaded with sand and also searched surrounding but could not trace out the owner and driver or any other. Hence seized the above noted tractor Mahindra B275DI, Bhumi Putra (Red Colour) having Rag. No- WB55A/6502 with trolley loaded with approx 100 cft sand. There is every reason to believe that the driver and owner of the above-mentioned Tractor with ill motive are transporting & lifting sand illegally without any valid document in support of carrying / Lifting sand and they habitually deal with the business of stolensand in a clandestine manner since few days. Hence, I seized the said tractor with its trolley loaded with sand and brought to Manbazar PS for legal action.

Therefore, I pray before you that a case may kindly be started against the driver and owner of the above-mentioned Tractor.
