Sir,

In producing here with one arrested accused person namely Kartik Tudu (26Yrs) S/O- Subash Tudu of Village- Choto Karma P.S. Bandwan Dist Purulia along with seized article 1) One "HYVA" Truck vide Registration No- WB67B-7455 loaded with sand approx 600 (Six Hundred) Cft. I S.I. Biswarup Roy of Manbazar PS do here by lodge a complaint against accused namely Kartik Tudu (26Yrs) S/O- Subash Tudu of Village- Choto Karma P.S. Bandwan Dist Purulia and Regd. Owner of the Hyva truck bearing registration No WB67B-7455 to the effect that today (15.06.22) at 16.45 hrs while myself along with force were performing mobile duty in Manbazar PS area at that time received a source information that a large scale of illegal transportation of sand is going on towards Basudi side. Then I informed the said information to O.C Manbazar P.S and as per kind direction of O/C Manbazar PS, I along with force left for working out the information. While myself along with force arrived at Samda More under Manbazar P.S found that 01 (one) HYVA Truck was proceeding from Pairachali side. Then I along with force intercepted the vehicle "HYVA" Truck vide Registration No- WB67B-7455 loaded with Sand at 17.05 hrs. On being asked, the driver of the said vehicle disclosed his identity as Kartik Tudu (26Yrs) S/O- Subash Tudu of Village- Choto Karma P.S. Bandwan Dist Purulia. On physical verification it is found that the Hyva bearing Regn No WB67B-7455, loaded with sand approx 600 (Six Hundred) Cft. I asked the driver of the vehicle to produce the valid documents in respect of the vehicle as well as the loaded sand. But the driver of the said vehicle could not able to produce any kind of documents in respect of the vehicle and the sand loaded in it. Driver of the vehicle stated differently in different times. The incoherent statement of the driver purported to be a suspicious. So there was every reason to believe that the driver of the above noted hyva truck along with the owner of the said vehicle procured the sand by illegal means for selling the same to make profit dishonestly and thus they have been running this clandestine business for wrongful gain. Finding no other alternative I seized the "HYVA" Truck vide Registration No- WB67B-7455, loaded with sand approx 600(Six Hundred) Cft. under proper seizure list in presence of available witnesses duly signed by them and arrested the driver namely Kartik Tudu (26Yrs) S/O- Subash Tudu of Village- Choto Karma P.S. Bandwan Dist Purulia after observing all legal formalities regarding arrest.

I therefore pray that a specific case may kindly be started against arrested accused person Kartik Tudu (26Yrs) S/O- Subash Tudu of Village- Choto Karma P.S. Bandwan Dist Purulia and Regd. Owner of the said vehicle as per law and arrange for its investigation.
