Sub: - To lodge FIR against owner and driver of Mahindra B275DI, (Red Colour) having Regn. No- WB55A/3367 attached with trolley (without number plate) loaded with sand.

Sir,

In producing herewith one seized tractor bearing Regn. No WB55A/3367 Mahindra B275DI, (Red Colour) attached with trolley (without number plate) loaded with sand fitted with approx 100cft sand. I beg to submit regarding the fact that today i.e on 19.06.2022 I, A.S.I. Sambal kr. Singh along with C/460 Nirmalendu Singha Mahapatra and C/967 Basudev Singh Mura were engaged in evening mobile duty in PS area vide Manbazar P.S C.C No 2126/22 dated 19.06.22 and GDE No- 693 dt- 19.06.2022. During mobile duty at 18:05 hrs received a credible source information that the above noted vehicle (Tractor) is lifting sand illegally at Kumari river bed at village Janara under Manbazar PS. I informed the matter to O/C Manbazar PS and as per his direction I along with force had been to Janara village side to work out the information. When we reached at Janara morh at 18:35 hrs found that one tractor was coming from Kumari river side. Seeing the police party driver of the tractor fled away from the spot leaving the sand loaded tractor. We chased him but could not able to intercept him. We searched the said tractor and found that the tractor is attached with a trolley loaded with approx 100 cft sand. Registration No of the said tractor is WB55A/3367 Mahindra B275DI, (Red Colour) but the trolley loaded with sand was without number plate. We searched the tractor to find out any valid documents in respect of the said tractor as well as the sand loaded in it but could not be found anything. There is every reason to believe that the driver and owner of the above-mentioned Tractor with ill motive are lifting & transporting sand illegally without any valid documents in a clandestine manner for their wrongful gain. Finding no other alternative I seized the said tractor with its trolley loaded with approx 100 cft sand under proper seizure list in presence of witnesses duly signed by them and brought to Manbazar PS for legal action.

Therefore, I pray before you that a case may kindly be started against the driver and owner of the tractor bearing registration No WB55A/3367 and arrange for its investigation.
