Sir,

In producing here with 01 (One) arrested accused person Kripasindhu Kumbhakar (40 yrs) S/O- Lt. Dwijapada Kumbhakar of village- Kadma, PS- Manbazar, Dist- Purulia along with seized motor Cycle bearing Regn No. WB56M/0654 (Red & Black colour Hero HF Delux) with all connected papers.

I beg to state that today i.e on 23.06.2022 in course of my mobile duty vide Manbazar PS GDE No- 853, dtd 23.06.2022 I had been to Indkuri morh area at 16:35 hrs and at 16:45 hrs found that the above noted person with his motorcycle bearing regn No WB56M/0654 (Red & Black colour Hero HF Delux) was coming from Chowk Bazar morh side with excessive speed and rough driving in negligence manner without wearing protective head gear. Myself along with force signaled to stop him but the driver of the said Motorcycle drove speedily and disobediently and tried to flee away. Somehow we could be able to detain him at near Indkuri bypass morh on Purulia - Manbazar road under Manbazar PS. This rough and negligence driving of driver would lead to an accident at any time. Any passerby could be injured by such activities. On being asked the above accused person could not be able to give any satisfactory answer for that movement on road and public place by such rough driving. So I arrested him at 17:05 hrs for rough and negligent driving and disobeying the order duly promulgated by public servant, after maintaining all rules of arrest, Issued memo of arrest. On being asked he could not able to produce the valid documents in respect of said motor cycle. So I seized the said motor cycle bearing Regn No. WB56M/0654 (Red & Black colour Hero HF Delux) in between 17:15 hrs and 17:25 hrs after preparing proper seizure list duly signed by the witnesses.

So a specific case may be initiated against Kripasindhu Kumbhakar (40 yrs) S/O- Lt. Dwijapada Kumbhakar of village- Kadma, PS- Manbazar, Dist- Purulia as per law and arrange for its investigation.


