Respected Sir,

With due respect I SI Biswajit Banerjee, beg to submit before you that on 14/06/2022 at about 07:45 hrs while myself along with force 1) C/680 Biswanath Roy 2) C/1319 Soumen Koley and 03) NVF/660 Ranjit Kumbhakar were performing Night mobile duty vide Neturia PS CC No-1904/22 Dated-13/06/2022 at Sarbari More on Purulia-Barakar Road (SH-5). I found one vehicle was coming from Raghunathpur side towards Neturia side with driving at excessive speed. Police personnel, present their in proper Police uniform raised hand and directed him to stop the vehicle but he violated the Police Signal and endangering human life by rash and negligently driving of the vehicle which may cause accident to the road user any time. After long chase we can able to apprehend him at Bhamuria More. On interrogation he made incoherent statement at different time. He disclosed his identity as Moti Lal Singh (55 Yrs) S/O- Harihar Singh of Vill- Garhata, Kalla, P.O- Brahampur, PS-Brahampur, Dist-Buxer, Bihar. On being asked he failed to produce any valid documents of the said vehicle. Hence he violated the provision of Section 279 IPC/184 MV Act. So, I seized the vehicle having Regd. No- WB37C/6899 at 08:15 hrs to 08:25 hrs under proper seizure list duly signed by the witnesses and arrested the offending driver namely Moti Lal Singh (55 Yrs) S/O- Harihar Singh of Vill- Garhata, Kalla, P.O- Brahampur, PS- Brahampur, Dist-Buxer, Bihar at 08:35 hrs avoiding by all the procedure as laid down in Cr.P.C and the latest guide lines of the Apex Court. As the offence is bailable, hence the accused driver namely Moti Lal Singh was released on bail after furnishing proper bail bond.

So I pray before you that a specific case may kindly be registered against the accused driver namely Moti Lal Singh (55 Yrs) S/O- Harihar Singh of Vill- Garhata, Kalla, P.O- Brahampur ,PS-Brahampur, Dist-Buxer, Bihar vehicle having Regd. No- WB37C/6899 committing offence U/S-279 IPC/184 MV Act.
