On Dated 20.06.2022 at about 2:00 A.M near Ramming Mass Store -SMS, due to reckless and Carelessness driving Of JCB driver namely -SK Imamul.S/O- SK Alil residing at Vill- Namodigha Po- Digha, Ps- Neturia, Purulia. WB, Pin-723121 having Vehicle No- WB38AU5494, the Vehicle has Struck off the left side hip by the front wheel of the vehicle to one of our Labour namely Kajol Gorai S/O-Fatik Gorai residing at Ajodhya Para, Guniyara, Ajodhya, Gunera, Purulia, West Bengal, Pin- 723133 Who was sleeping in the above said site in his recess hour. After that the area shift - in-charge, informed security at main gate for ambulance. Then after, he was immediately taken to Harmadiah Hospital but having seen the criticality of injured person, the Harmadiah hospital referred him to Purulia Sadar Hospital for further treatment where he was declared death by attending medical officer during treatment at around 6:00 A.M on 20.06.2022.

So, you are hereby requested to lodge a complaint against the above said JCB driver & also do needful in this matter from your good end as per provision of law so that the victim's family can get fair & responsible justice.
