Dear Sir,

I do hereby lodge written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 to the effect that **Reyajuddin Sekh, S/O- Jainul Sekh**, a permanent resident of **Vill- Heddi, P.O -Digha, P.S -Neturia, Dist- Purulia** has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On **28.06.2022** at about **01:00PM** I, Dhritiman Sardar S/O- Rupal Sardar, aged about 24 years, AE & SM Saltore CCC, along with Sri Souvik Mudi, J.E. (Gr-II), Saltore CCC, Goutam Kr Pandey, HgTSH, Saltore CCC and others had been to the village- Heddi for routine inspection purpose. During inspection it was found that **Reyajuddin Sekh was consuming electricity dishonestly and unauthorisedly in his Domestic premises by the way of direct hooking from nearby LT mains of WBSEDCL causing considerable loss of revenue of WBSEDCL to the tune of load 0.20 KVA.**

As theft of electricity was detected during inspection the illegal hooking line was disconnected & removed from the nearby electrical source and one number two core flat type black coloured 4 sqmm alluminium PVC cable along with hooking devices of assorted size has been seized under memo of seizure list in the presence of witnesses and their signature is also duly obtained in the seizure list. Reyajuddin Sekh acknowledged the same by putting his signature in the Seizure List, Inspection Report and label. The above seized materials duly packed and labeled at the inspection site and signature of the WBSEDCL representative as well as the representative of the accused has also been obtained on the label. After completion of inspection, the inspection team left the aforesaid premises at about **01:25PM**.

Thus the accused **Reyajuddin Sekh, S/O- Jainul Sekh, Vill- Heddi, P.O -Digha, P.S -Neturia, Dist- Purulia** have committed an offence u/s 135(i)(a) of the Electricity Act 2003 read with Amendment Act 2007.

You are requested to take cognizance of this complain treating it as FIR.
