I beg to submit that today (04.06.2022) during my evening mobile duty, I received credible source information that one Khepakar Mahato (60yrs) S/o Lt- Musuri Mahato of village- Bhowridih, PS- Para, Dist- Purulia has stored huge quantity of Country Spirit for selling. Accordingly I informed to O/C Para PS and as per his instruction in between 19.45 hrs to 20.15 hrs I held raid in the house of Khepakar Mahato (60yrs) S/o Lt- Musuri Mahato of village- Bhowridih, PS-Para, Dist-Purulia and found that the above noted person was selling Country Spirit contained in bottles named as "DIL KHUSH". On seeing Police the people who were buying Country Spirit fled away. I asked the above noted person to produce license for selling such Country Spirit, but he did not have any authorization or license in support of said Country Spirit. So I seized 18 (Eighteen) bottles of "DIL KHUSH" Country Spirit containing 600 ml each which were kept in his house. I prepared seizure list and label in presence of witnesses duly signed by them. I also arrested the above noted person maintaining all rules and guideline as laid down by NHRC/WBHRC and informed his family members.
