

On 29-05-2022 at about 10 A.M. in the field of complainant within R.S./L.R. Plot no -888, comprising an area 4.88 acre Within mouza: Dheria under P.S Para, Dist: Purulia under limit of Ld. Court.

OFFENCE COMMITTED U/S:-447/379/411/427/506/34 I.P.C.

> The complainant most respectfully beg to state as follows:-

- 1. That the complainant is a permanent resident of village:-Dheria and lawful owner of R.S. Plot no.888 an area 4.88 acre of mouza: Dheria having occupancy and possessmy right thereon.
- 2. That the complainant is a nature lover and have transplanted several as much as 250 saplings of few varieties trees v/Z Arjum Neem, sirish, Jam, palash etc. over or within aforementioned property few years ago which were sufficiently grown up under the number of complt. The complt have also built up two rooms dwelling house over the said property besides that he has a bore well there.
- 3. That the accd persons are very much determined to commit mischief with the person and properties of the complainant and they are the local inhabitant of complt. having involvement wit criminal activities and they are notorious fortheir antisocial activities.





4. That on the day of incident at relevant point of time in absence of complt. all the accd. persons in order to fulfill their common intention alongwith their associates entered into the said property of the complainant having equipped with cutting object like Axe, saw and transporting vehicles like tractors, J.C.B. machine and cutt-down sirish, Arjun, Neem, Jam various trees as much 150 number collectively within the land of complt. illegally without any permission from the complainant. The acced persons also tookaway the trunks and branches of said trees from the land of complt. in broad day light with their high handed action.

- 5. That as soon the complt. came across such illegal and overt act of the accd. persons he raised protest but accd. persons became so furious and gave out threat "BESI PROTIBAD KORISNA, DARKARE TOKE JIBONE SESH KORE DEBO". the accd. persons also disclosed that very soon they will cut and take away other standing trees from the aforesaid land of the complt. and even required in exchange life of the complainant.
- 6. That since then the complainant is passing his days under grave threat of the accd. persons, the complainant also apprehends that his life may be endangered in the had of the accd. persons if he raise further protest, since they are committed to do mischief with the property of complainant.
- 7. That the witnesses have seen the incident but for the sake of their life they could not raise their voice against the culprits.



8. That the complainant informed the incident in writing to the local police station at PARA on 30-05-2022 in which P.S. concern assured the complt. as "DEKCHHI DEKHBO" but did nothing. Thus the complt. sent his grievances to the S.P. Purulia through Regd. post on 04-06-2022 but till date no effective measure come out against the accd. person, as a result the accd. persons are moving in the locality in with their headheld high.

9. That finding no other alternative, taking the last recourse for his grievance complt. seeks his remedy before the Ld. court.

Therefore the complainant prays before the Ld. court to pass an order upon the O.C Para directing him to cause investigation into the matter after starting a specific case against the accd. persons treating the instant petition as F.I.R. under Sec. 156(3) of Cr.p.C...
