Sub: Complaint for starting a specific case.

In producing herewith one (01) Tractor bearing Reg No- WB55A-9125 along with one trolley without registration number, loaded with sand approx 100 cft under proper seizure list. I beg to submit that today (05/06/2022) I, SI Sujoy Kundu along with C / 1260 Santosh Saren & C/1412 Susanta Patra all of Puncha PS were performing anticrime day mobile duty at PS area vide Puncha PS CC No - 1140 /22 Dt-05/06/22 and at about 10:55 hrs, I received credible from duty officer that one Tractor is standing at near Hanridhua more near Surigora village on Koira to Goplanagar concrete road under Puncha PS loaded with sand illegally. Accordingly I intimated the matter to you over phone and as per your direction we reached Hanridhua more near Surigora village on Koira to Goplanagar concrete road to intercept the above noted Tractor and at about 11:25 hrs we found that above noted Tractor ready to go from Suridih Ghat side towards Gopalnagar side but on seeing the police party the driver of above noted vehicle (Tractor) suddenly stopped approx 30/50 meter away from us, got down from the vehicle and started running. We chased to apprehend him but we failed to apprehend him. Then we searched the vehicle(tractor) and found that the vehicle (Tractor) having registration No- WB55A-9125, along with trolley loaded with sand 100 cft but after searching no any document could be found regarding above noted Tractor along with trolley loaded with sand approx 100 cft.

So, there is reason to believe that the driver and registered owner of this vehicle (tractor) have collected the said sand either by theft or by any fraudulent means and after hatching a criminal conspiracy, they were trying to dispose off the same at anywhere in a clandestine manner knowing it to be stolen as per their regular practice.

Accordingly I seized the Tractor bearing Registration No WB55A-9125 along with trolley without registration number loaded with sand approx 100 cft. under proper seizure list duly signed by witness. So the driver and registered owner of this vehicle (Tractor) of the said tractor have committed offence u/s- 379/411/413/414/120B IPC & 21 (1) (4) Mines and Minerals (Development and Regulations) act, 1957.

Under the above fact and circumstances a specific case may kindly be started against the driver and the registered owner of this vehicle(Tractor) bearing Reg. No- WB55A-9125, U/S - 379/411/413/ 414 and Minerals (Development and Regulation) Act - 1957 and arrange its investigation.
