Sub: Prayer for starting a specific case.

Respected Sir,

In producing herewith one accd. person namely Raju Bauri @ Gaju (32 yrs) , S/O- Bahadur Bauri of vill-Barameshya, PS-Puncha , District- Purulia with seizure of 15 pcs. Sealed bottles of Dil Se country spirit containing 600 ml. each which were seized and labeled under proper seizure list.

I beg to submit that today (10.06.22) at 17:15 hrs while myself along with C/617 Mrityunjoy Sahana and C/580 Pradip Kr. Bag vide Puncha PS CC No-1182/22 Dated 10.06.2022 were performing Spl. Mobile duty at Budhpur side. During Spl. mobile duty received source information that one Raju Bauri @ Gaju (32 yrs) , S/O- Bahadur Bauri of vill-Barameshya, PS-Puncha , District- Purulia has illegally stocked liquor in house at Barameshya village under PS-Puncha & selling the same. On receiving the information, I informed the matter to you and as per your instruction myself along with force proceed to Barameshya Village to work out the information. At 17:35 hrs after reaching at Barameshya village and held raid in the house of Raju Bauri @ Gaju (32 yrs) , S/O- Bahadur Bauri of vill-Barameshya, PS-Puncha , Dist- Purulia and found that the above noted person was keeping / selling liquor which were kept in his house, on demand Raju Bauri @ Gaju failed to produce any valid documentary authority in respect of selling of liquor as well as nobody turned up to produce any valid documents. As such he committed offence u/s 46 A(c) B.E. Act. 1909. Accordingly I searched there and found 15(fifteen) sealed bottles of Dil Se country spirit containing 600 ml. each and , I seized the same and labeled under proper seizure list duly signed by witnesses as well as one of the same bottle is taken as a sample which is sealed and labeled . After seizure I arrested the Accd Raju Bauri @ Gaju u/s 67 of B.E. Act as he committed offence u/s 46 A(c) B.E. Act 1909. During arrest the ground of arrest was duly notified, issued arrest memo u/s- 50 Cr. P.C. and handed a copy of the same to arrestee. I also issued check list u/s-41 (1)(a), (b) (I), (II) Cr.P.C. Direction of the Supreme Court of India vide Criminal Appeal No.-1277 of 2014, Spl. Leave petition.

Under the above facts and circumstances I therefore pray that a specific case may kindly be started against the arrested Raju Bauri @ Gaju (32 yrs) , S/O- Bahadur Bauri of vill-Barameshya, PS-Puncha, Dist- Purulia under proper section of law.
