Sub: Complaint against Rakesh Rajwar.

Sir,

In producing herewith one arrested accd. person namely Ramesh Rajwar (24) s/o Ananda Rajwar of Vill-Damurdih Tola, Bongabari, PS-Purulia (M), Dist- Purulia with seizure list and seized articles.

I beg to submit that today (10.06.2022) while I was detailed to perform Spl. mobile duty in PS area along with force (i) C/1464 Bhagyadhar Patra & (ii) C/624 Pradip Chakraborty both of Purulia (M) PS vide Purulia (M) PS C.C. No 2300/2022 & GDE No 446 Dtd. 10.06.2022. During my Spl. mobile duty, I received a secret tip off that an illegal possession of huge quantity of Country spirit at Damurdih Tola under Bongabri village. Subsequently, I informed you and as per your direction, I rushed to the spot at Damurdih Tola under Bongabri village and after arriving at the spot and as per your instruction conducted raid in the shop of Ramesh Rajwar under this PS. During the raid 2/3 persons fled away and detained one person. On asking the identity he disclosed his name address as noted supra. On interrogation he confessed that he procured and stock the Country spirit for selling illegally from his shop. So that he could gain more amount from the selling of (liquors) Country Spirit. On demand he failed to produce any valid document in respect of selling and possession of said (liquors) Country Spirit from his shop. Subsequently, I seized 15 (fifteen) sealed bottles Dil Khush country sprite, each containing 600 ml. In which kept 01 sealed bottles as sample. I seized the same under proper seizure list in presence of witnesses and duly signed by witnesses and accused person. Consequently, I arrested the above noted accused person after informing him the ground of arrest and issued Memo of Arrest and observed all legal formalities in respect of the Arrest. The seized articles were properly sealed and labeled in presence of witnesses duly signed by them and accused person.

The above noted arrested person namely Ramesh Rajwar (24) s/o Ananda Rajwar of Vill-Damurdih Tola, Bongabari, PS-Purulia (M), Dist- Purulia committed offence U/S 46 A (c) of Bengal Excise Act. 1909 for unauthorized possession for selling of Country Spirit from his shop. Under the fact and circumstance kindly take necessary lawful action against Ramesh Rajwar (24) s/o Ananda Rajwar of Vill-Damurdih Tola, Bongabari, PS-Purulia (M), Dist- Purulia.
