Respected Sir,

In producing herewith one seized vehicle (Tractor) bearing Reg. No **WB55B-4307** attached with its loaded Sand Trolley and with proper Seizure list.

The fact brief is that today (22.06.2022) while myself along with force i) C/692 Ukil Ch. Mahato & ii) C/699 Biswajit Banerjee both of Purulia (M) PS left the PS for performing Day mobile duty vide Purulia (M) PS CC No 2417/2022 and GDE No 1162 Dt. 22.06.2022 in PS area. During my day mobile duty, I received a tip off at 16:45 hrs that one tractor driver & its owner were lifting sand illegally from Kasai river bed at Katabera Ghat and said suspicious tractor loaded with sand was coming from Katabera side towards Chas Morh. Subsequently, I along with force proceeded towards Katabera to work out the tip off. While I along with force arrived near Garafushra village and found that 01 (one) tractor was proceeding towards Chas Morh along Garafushra to Chas More village road. On being seen by the police party from far away, the driver of the said vehicle (Tractor) stopped the tractor & fled away to avoid the any touch of police. I along with force also chased the driver to detain but could not. Then I along with force intercepted the vehicle (Tractor) bearing Reg. No **WB55B-4307** attached with its Trolley loaded with Sand at 17:25 hrs and I found the vehicle as well as goods as identical as I received prior information. I also informed the matter to you and as per your kind direction, I along with force were awaiting long time but none could turn up before me. It was ascertained that the driver of the tractor loaded the said sand in cahoots with the owner of the vehicle by illegal means for selling the same to make profit by dishonestly and he have been running a clandestine business. So it is reasoned to belief that driver of the said vehicle in cahoots with the owner of the vehicle procured the said sand from Kansai River near Katabera Ghat by fraudulently means or theft by any means for transporting the same to run clandestine business. So I, seized the (tractor) bearing Reg. No WB55B-4307, attached with Trolley loaded with Sand approx. 100 CFT under proper seizure. Thereafter, I brought the seized tractor to Purulia (M) PS compound as per kind direction of you.

Under the above facts and circumstances kindly take lawful action against the drivers as well as owner of the vehicle (Tractor) bearing Reg. No WB55B-4307.
