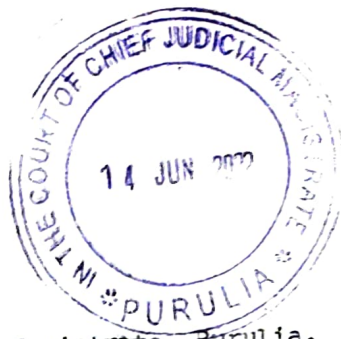

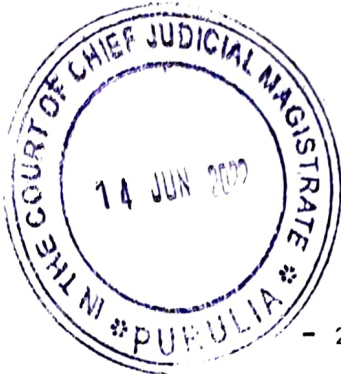

4. Rajkishore Singha son of Sri Shankar Prasad Singha, of village Loharsole, Post Dabar-Balaramour, P.S. Purulia (M), Dist. Purulia,

The above named complainant begs to state as follows:-

1. That, the complainant is the legally married wife , accused no. 1 and their marriage was solemnized on 02.05.2019 as per special Marriage registration Act at District Marriage Registrar office , Purulia.
2. That, after marriage the complainant was taken to her matrimonial home by the accused no. 1 and lives there with her husband i.e. accused no. 1 in her matrimonial home as husband and wife though her father-in-law and his brother i.e. accused no. 2 and 3 could not accept their marriage as the complainant belongs to schedule caste community and accordingly they obtain insult or intimidates the complainant with intent to humiliate in public and as such the complainant compelled to return back to her father's house at village Hutmura.
3. That, on 15th day of April, 2021 the accused no. 1 came to Hutmura and takes the complainant with him and went to Bankura where they stayed Chowdhury Lodge near Bankura Rail Station and being in a position to dominate the will

of the complainant and used that position to exploit her sexually in which the complainant would not have otherwise agreed. and on the next day i.e. on 16.04.2021 the accused No. 1 kept the complainant in her father's house at village Hutmura.



4. That, on 24.09.2021 the complainant along with his mother went to her matrimonial home and after reached there accused no. 1 assaulted the complainant with fist and blows and even he bites in the hand of the complainant and all the family members of her matrimonial home abuses her with filthy language and drove the complainant and her mother from their house even they prevent, obstruct them having access to a place (Panchayat Office) in which other members of any section have a right to access

5. That, on 28.12.2021 the complainant applied Kalyan Counselling Centre regarding their marital dispute and accordingly counsellor of the centre called both of them for counselling at Bongabari Family Counselling Centre, Purulia on 10.01.2022 where the accused no. 1 appeared and did such act with intent to cause injury, insult and annoyances to the complainant and accordingly reconciliation had not been possible by the counsellor.

6. That, thereafter the accused No. 1 institutes a vexatious suit against the complainant who belongs to Schedule tribe community in order to save himself from the offences he committed.

7. That, your Petitioner informed the matter to the Purulia (M) P.S. on.. 18.5.22 but no action has been taken from their ends.

8. That, the complainant informed the matter to the Superintendent of Police Purulia on 18.05.2022 but ~~action~~ no action has been taken from his ends hence this Petition

9. That, the complainant is heloless lady having no income of her own and not in a position to continue her case at her own capacity.

10. That, the matter is very serious in nature and accordingly police investigation required.

In the premises set forth above it is prayed that your honour may be pleased to send the Petition of complaint to the officer/Inspector in charge of Purulia(M) P.S. treating the same as F.I.R. under sec. 156(3) of Cr. P.S. for investigation.
