

2. That, after marriage the complainant was taken to her matrimonial home by the accused no. 1 and lives there with her husband i.e. accused no. 1 in her matrimonial home as husband and wife though her father-in-law and his brother i.e.

accused no. 2 and 3 could not accept their marriage as the complainant belongs to schedule caste community and accordingly they oftain insult or intimidates the complainant with intent to humiliate in public and as such the complainant compelled to return back to her father's house at village Hutmura.

3. That, on 15th day of April, 2021 the accused no. 1 came to Hutmura and takes the complainant with him and want to Bankura where they stayed Chowdhury Lodge near Bankura Rail Station and being in a position to dominate the will
