Respected Sir,

In producing herewith the driver namely Nirmal @ Majhi Gope (28 Yrs) S/O Sitaram Gope of Vill- Teledih, PO- Satra, PS- Tamna, Dist- Purulia along with one seized New Holland Tractor Bearing Regn. No. WB55A-7068 attached with Trolley loaded with Sand and with Seizure list, Memo of Arrest and Inspection Memo in respect of the above noted persons before you.

The fact brief is that today (18.06.2022) at 12:45 hrs while I along with force 1) C/1252 Sunil Mondal 2) C/2962 Ujjal Mahanti both of Purulia (T) PS left the PS for day mobile duty vide Purulia (T) PS CC No 1523/2022 and GDE No 1209 Dt. 18.06.2022 in PS area. During my day mobile duty, I received a tip off at 17:35 hrs that a suspicious tractor loaded with sand was coming from Bhatbandh side towards Victoria School More. Subsequently, I along with force proceeded towards end of our P.S area to work out the tip off. While I along with force arrived near at Victoria School More under Purulia (T) PS and found that 01 New Holland Tractor was coming towards Victoria School More via Mission road. I along with force intercepted the New Holland Tractor bearing No.WB55A-7068 attached with Trolley loaded with Sand at 18:05 hrs at Victoria School More and I found the vehicle as well as goods as identical as I received prior information. On being asked, the driver of said vehicle disclosed his name noted in the above. I asked the driver of the vehicle to produce the valid documents in respect of the vehicle as well as the loaded sand. But the driver of the said vehicle could not able to produce any kind of documents in respect of the Tractor as well as carrying sand. I repeatedly asked the driver to produce the valid paper but he stated incoherent statement in different times. The incoherent statement of the driver purported to be a suspicious to us. It was ascertained that the driver of the tractor loaded the said sand in cahoots with the owner of the vehicle by illegal means for selling the same to make profit by dishonestly and they have been running a clandestine business. So it is reason to belief that he in cahoots with the owner of the vehicle procured the said sand form Kansai River under Tamna PS side by fraudulently means or theft by any means for transporting the same to run clandestine business. So I seized the New Holland Tractor Bearing Regn No. WB55A-7068 attached with Trolley loaded with Sand under proper seizure list in presence of available witnesses duly signed by them and also arrested the driver Nirmal @ Majhi Gope (28 Yrs. approx.) S/O Sitaram Gope of Vill- Teledih, PO- Satra, PS- Tamna, Dist- Purulia after informing the ground of his arrest and issued Memo of Arrest and Inspection Memo against him. Thereafter, I brought the seized tractor to Purulia (T) PS compound.

Under the above facts and circumstances kindly take lawful action against the owner of the tractor bearing No. WB55A-7068 and the arrested driver of the tractor namely Nirmal @ Majhi Gope (28 Yrs.) S/O Sitaram Gope of Vill- Teledih, PO- Satra, PS- Tamna, Dist- Purulia of the vehicle as they committed offence u/s 379/411/414 of the IPC & 21(I) (4) of Mines and Minerals (R&D) Act-1957.
