




No. 1 is the resident of Huchuk Para , Mission Road , Purulia , P.O. \star P.S. & District Purulia.

No. 3 is the resident of Chaibasa Road , purulia , P.O. + P.S. & District Purulia .


Facts of the case : -

- 1. That the above named complainant being the permanent resident of purulia is and Id physically handicapped lady residing at ward No. 5 in holding no. 36/1 residing alone in the said holding.
- 2. That due to such physical handicappedness and old age being afraid of foul play by any one the complainant contracted with the accused as he was the previous acquinted person with the family with and disclosed about her loelinees and help-lessnes to him.
- 3. That thereafter the accused showed her interest to look after the property and requested the complainant to get a Registered Power of Attorney in favour of him for necessary Looking after the property.
- 4. That the complanant beleving him was agreed to give him the power of Attorney only to look after the property on 02.07.2019, which was written by deed writer as per the instruction of the occused.



- 5. That subsequently when the complainant received two (02) notices from the Court which also were handed over to the accused but the accused did not give any information about those cases for a **fonsiderable** period, when the complainant requested the witness No.2 to bring out the information about the cases from the court, when complainant came to know that vittually no step ϕ for contesting the cases has been taken by the accused.
- 6. That the complainant further came to know that the accused has sold out the property in favour of his wife Smt.Subhadra Gorai for which second case has been started for violating the injunction order.
- 7. That the reafter the complainant brought the certified copy of the deed on 20.02.2022 and found that the deed in question has been executed and registered by the accused in favour or his wife on 09.02.2019 in the house of the accd. and registered on 11.07.2019 and the consideration money has been shown as \$\inser* 30,00,000/- (Thirty Lakhs) though valuation was assæred of \$\inser* 45,65,000/- but neither any information, regarding the selling out of land nor any money was paid to her.

 8. That the complainant stating every facts lodged an information at Purulia (T), P.S. on 14.03.2022 but as no step was taken by the 0.°C. Purulia (Town) P.S. the complainant submitted an application before the S.P. Purulia on 22.03.2022 but neither the 0.°C. nor the S.P. Purulia has conducted any enquiry investigation on the facts of the case, the complainant has been complled



to file this petition before this learned court
