

## An Application Under Section 156(3) of Cr.P.C.

The humble petition on behalf of the above named complainant:

## Most respectfully sheweth as follows:

- 1. That your complainant is the peace loving and law abiding citizen and holds a respectable position in the society, whereas on the other hand all the accused persons are very dangerous and desperate in nature and having no regards to law at all.
- 2. That the homestead property mentioned in the schedule hereunder are your complainant's ancestral property which her brother alongwith other co-sharer acquired by way of registered gift deed and the schedule mentioned homestead property originally belonged to your complainant's father SK. Ahmad Ali Saudagar ( since deceased ) but before his death he has equally divided the said property between two brothers of your complainant by registered gift deed.





- Thereafter your complainant two brothers has duly been recorded or mutated their name in the record being Holding no. C-72, Measuring an area 10 Cottah, Khatian no. 10, Classification Bastu, Mouza: Purulia, J.L. no. 292.
- 4. That further your complainant is going to state that Gulam Mustafa (since deceased) who was/is her elder brother died living behind the above named assailant no. 1 & 2 as his legal heirs but misfortune swallows all their charm and happiness after the sudden demise of complainant's elder brother and father because after their death the above named assailants started showing their true colours as ZOHRA BEGUM who is assailant no. 1 is a very shrewd and cunning lady who had a vulture eyes over the portion of other sharer i.e, Mubarak Ali in the schedule mentioned property since long and she most wrongfully, illegally, forcefully and surreptitiously in collusion and connivance with her SON ZEESHAN AHMAD managed to or illegally acquire the possession in respect of the schedule mentioned property inspite of the fact that the said property has been recorded in the name of two brother.
- 5. That at the initial stage the above named assailants tried a lot to acquire Mubarak Ali's portion over the said property by any means and many of times they have shown some false documents and asked your complainant to sign on the paper but she refused to do so. When they failed from every side then they started to quarrel with your complainant by assaulting and also trying to illegally and forcefully evict and dispossess her and other co sharer from the schedule mentioned property and creating disturbance in her peaceful possession and occupation of the said property.
- 6. That due to the torture level of accused persons she alongwith her brother Mubarak Ali and other un-married sisters Shifted to Kulti, Patiana Mohalla and started to reside there after putting lock and keys in the said below mentioned schedule property.
- 7. Thereafter in the year 2011 when your complainant went to see her brother Mubarak Ali's schedule mentioned property to her utter surprise she found that the above named assailants already took possession of the part portion in the said property after breaking the key and lock. After seeing all this she has filed a case against them before the Purulia Police Station and the said case was registered being Purulia PS case no. 108/2011. Later again your complainant asked them to leave the said portion property but they become more violent and threatened your complainant and Mubarak Ali in dire consequences threatening to kill her if she asks them about the same and till date she is continuously requesting them to handover the said property but all went in vain.





- 8. That on 31/03/2022 again your complainant went to her brother Mubarak Ali's schedule mentioned property with her sisters but after seeing them they became even violent and started abusing them using filthy languages and even pushed them out from their house and took all her house hold utensils like, furniture and all worth Rs. 20,0000,000/-.
- 9. Thereafter on 31/03/2022 your complainant went to Purulia PS to lodge her complaint in written form which was duly received by the duty officer but no any action has been taken by the Purulia PS till date. Also, I have sent a letter against their illegal activity to the International and National Human Rights Commission.
- 10. That after passing of more then one month no action has been taken by police officers of Purulia PS which compelled the complainant to inform this matter to Superintendent of police, Purulia through speed post on 02/05/2022 which was duly delivered to Purulia SP on 04/05/2022 but it yield no fruitful result till date.
- 11. That now your complainant has no alternative option but to knock the door of Court as no action has been taken by any authority for the ends of justice..

That thus the accused person has crystal clear committed an offence under section: - 200/200/400/400/400/1000 of IPS. Had 12/05/10

It is therefore prays before Ld. Court to pass such necessary order directing the Officer in Charge of the Purulia P.S to treat this complain as F.I.R under section 156(3) Cr.P.C and enquire into the matter as soon as possible and pass such necessary order or orders as the Ld. Court may deem fit and proper.

And for this act of kindness your petitioner as in duty bound shall ever prays.
