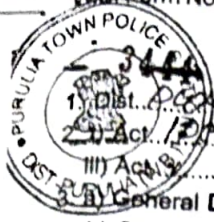

Respected Sir,

In producing herewith the driver namely Sanjit Gope (21 Yrs. approx.) S/O Bhabataran Gope of Vill- Haranama, PO- Beldih, PS- Arsha, Dist- Purulia & along with seized vehicle (Tractor) Bearing Reg. No. WB55A-6750 attached with loaded Sand Trolley without any number Plate and with Seizure list, Memo of Arrest and Inspection Memo in respect of the above noted persons before you.

The fact brief is that today (04.06.2022) at 06.55 hrs while I along with force 1) C/2353 Sajal Kundu 2) NWF 852 Rupsing Beava both of Purulia (T) PS left the PS for day mobile duty vide Purulia (T) PS CC No 1385/2022 and GDE No 156 Dt. 04.06.2022 in PS area. During my day mobile duty, I received a tip off at 12:45 hrs that a suspicious tractor loaded with sand was coming from Kansai river side towards Bhatbandh More. Subsequently, I along with force proceeded towards end of our P.S area to work out the tip off. While I along with force arrived near at Kamarpasa under Purulia (T) PS and found that 01 (one) tractor was coming towards Bhatbandh More along Bhatbandh-Beldi road. I along with force intercepted the vehicle (Tractor) bearing No. WB55A-6750 attached with Trolley loaded with Sand without any number plates at 13:05 hrs and I found the vehicle as well as goods as identical as I received prior information. On being asked, the driver of said vehicle disclosed his name noted in the above. I asked the driver of the vehicle to produce the valid documents in respect of the vehicle as well as the loaded sand. But the driver of the said vehicle could not able to produce any kind of documents in respect of the tractor as well as carrying sand. I repeatedly asked the driver to produce the valid paper but he stated in coherent statement in different times. The incoherent statement of the driver suspected to be a suspicious to us. It was ascertained that the driver of the tractor loaded the said sand in cahoots with the owner of the vehicle by illegal means for selling the same to make profit by dishonestly and they have been running a clandestine business. So it is reasoned to belief that he in cahoots with the owner of the vehicle procured the said sand from Kansai River under Purulia (M) PS side by fraudulently means or theft by any means for transporting the same to run clandestine business. So I, seized the (tractor) Bearing No WB55A-6750 attached with Trolley loaded with Sand without any number plate under proper seizure list in presence of available witnesses duly signed by them and also arrested the driver 1) Sanjit Gope (21 Yrs. approx.) S/O Bhabataran Gope of Vill- Haranama, PO- Beldih, PS- Arsha, Dist- Purulia after informing the ground of his arrest and issued Memo of Arrest and Inspection Memo against him. Thereafter, I brought the seized tractor to Purulia (T) PS compound.

Under the above facts and circumstances kindly take lawful action against the owner of the tractor bearing No. WB55A-6750 and the arrested driver of the tractor namely Sanjit Gope (21 Yrs. approx.) S/O Bhabataran Gope of Vill- Haranama, PO- Beldih, PS- Arsha, Dist- Purulia of the vehicle as they committed offence u/s 379/411/414 of the IPC & 21(i) (4) of Mines and Minerals (R&D) Act-1957.
