

Request for lodging F.I.R. against arrested accused person namely Chanu Pandey (42 yrs) s/o-Lt. Aswini Kr. Pandey of Nimtard, Near Durga Mandir and Kali Mandir, Ward No- 05, PS- Purulia (T), Dist- Purulia A/P Zilla School More, Tamli Para, Ward No- 08, PS- Purulia (T), Dist- Purulia.

In producing herewith one arrested accused person namely Chanu Pandey (42 yrs) s/o- Lt. Aswini Kr. Pandey of Nimtard, Near Durga Mandir and Kali Mandir, Ward No- 05, PS- Purulia (T), Dist-Purulia A/P Zilla School More, Tamli Para, Ward No- 08, PS- Purulia (T), Dist- Purulia under arrest memo alongwith seized articles under proper seizure list and being labeled properly namely:-

- 17 (Seventeen) bottles of Country Spirit designed as 'Dil Khush' (each bottle contains 600 ml of country spirit having strength 80° UP and MRP is Rs 50/- being sealed properly) blended and bottled by Purulia Bottling Pvt. Ltd., Vill+ PO Lagda, Dist. Purulia, Pin 723149.
- 2) Out of 17 (Seventeen) bottles 01(one) bottle is kept as sample.

I, ASI Malay Sarkar, beg to report that while I was performing evening mobile duty vide Purulia (T) PS GDE No- 554 dated 10.06.2022, at about 15:25 hrs I received a secret telephonic information from source that one person namely Chanu Pandey (42 yrs) s/o- Lt. Aswini Kr. Pandey of Nimtard, Near Durga Mandir and Kali Mandir, Ward No- 05, PS- Purulia (T), Dist- Purulia A/P Zilla School More, Tamli Para, Ward No- 08, PS- Purulia (T), Dist- Purulia was selling country spirit illegally at a higher price causing unlawful gain to him by unlawful loss to the purchasers in his house at Purulia Zilla School More Tamlipara, Ward No. 8, PS- Purulia(T), Dist .- Purulia.

Accordingly I informed the matter to I/C, Purulia (T) PS and after getting his permission myself alongwith my team consisting of C/295 Badrul Hazari and C/1252 Sunil Kr. Mondal all of Purulia (T) PS proceeded to work out the information.

After sometime we reached at Purulia Zilla School More, keeping our Govt. vehicle at a reasonable distance we proceeded towards Zilla School More Tamlipara, Ward No. 8 as shown by the source from the distance and found that the said person was selling Country Spirit as noted above to some persons and some persons were found drinking there. Seeing the police, all of them tried to flee away leaving some plastic glasses at the spot. On hot chase one of them could be nabbed. On interrogation the said person disclosed his identity as noted above. On search of the house we found 17 (Seventeen) bottles of Country Spirit designed as 'Dil Khush' (each bottle contains 600 ml of country spirit having strength 80° UP) blended and bottled by Purulia Bottling Pvt. Ltd., Vill+ PO Lagda, Dist. Purulia, Pin 723149. On further interrogation Chanu Pandey stated that the said place was his residence and was selling Country Spirit as noted above to the locals without having any authority at a higher price since long. He also failed to produce any license in favour of selling, keeping or possessing Country Spirit. As such at about 15:55 hrs to 16:15 hrs I seized the above noted Country Spirit under proper seizure list in presence of witnesses after labeling and sealing properly. I also took samples and arrested him observing all the formalities as the said person committed an offence which attracts sec. 46 (A) (C) of B.E. Act 1909.

Hence, I pray before you to start a specific case against the above noted person under proper section of law and kindly arrange for its investigation.
