Sir, I solemnly submit that I have been granted a permanent Permit on the route: Joydev to Purulia (Exp) vide no. WB-2021-SC-0155A on 29.11.2021. As soon as I started plying my subject bus, it was intercepted by the persons named below:—

- and others, and they threatened my workers with dire consequences. Thereafter, apprehending damage to my bus, my bus did not ply upto Purulia for long. Thereafter I again send my bus to Purulia on 22.5.2022. As soon as it reached Purulia bus stand, it was captured by the abovenamed persons and their associates. They also assaulted my bus-workers and held-up my bus.

As they have obstructed my bus's lawful plying, by taking the law in their own hand, without any cogent & valid reason, I do hereby pray to prosecute the accused, and to ensure smooth plying of my bus in accordance with my permit.
