Respected sir,

In producing herewith one seized vehicle (Blue colour tractor with trolley loaded with sand) having Registration number WB55B/5156, Engine No.- RMC2BBN0903 & Chassis No: MBNABACAAMRC08682, attached with Seizure List. The nub of the fact in a nutshell is that today (12.06.2022) while I, along with C/1457 Nityaranjan Rajwar & HG/1787 Uttam Kumar, were performing mobile duty vide Santaldih PS GDE no. 468, dated 11.06.2022, in Santaldih PS area, I, received a tip off at 07:45 hrs on 12.06.2022 that, near Shyampur more under Santaldih PS, some persons were illegally carrying sand by a suspicious tractor. Subsequently, I along with force proceeded toward Shyampur more to work out the tip off. While, I along with force arrived at Shyampur more under Santaldih PS and found that, some persons are illegally carrying sand into a tractor attached with trolley.

I, along with force proceeded to detain the vehicle and reached at the spot i.e. Shyampur more near Kali temple, PS - Santaldih at 07:55 hrs but seeing the police persons the driver left the Blue Colour Tractor having Registration number WB55B/5156, Engine No.- RMC2BBN0903 & Chassis No: MBNABACAAMRC08682, attached with trolley loaded with sand and fled away. I tried to find out the name & address of the driver / owner of the tractor but in vain.

During enquiry, it is ascertain that the driver of the said tractor loaded the said sand in cahoots with the owner of the vehicle by illegal means for selling the same to make profit by dishonestly and they had been running a clandestine business by transporting the same at Jharkhand State. So, it is reason to believe that they in cahoots with the owner of the vehicle procured the said sand from Harai river bank (Harai Nadi Ghat), by fraudulently means or theft by any means for transporting the same at Jharkhand State to run clandestine business. As per source information, they are habitual offender of this crime, as they have been engaged in the said illegal sand leafing business since long, behind the eyes of the administration.

So, I, seized the said blue colour tractor having registration number WB55B/5156, Engine No.- RMC2BBN0903 & Chassis No: MBNABACAAMRC08682, attached with the trolley loaded with sand under proper seizure list in presence of available witnesses duly signed by them. Thereafter, I brought the seized tractor along with the loaded sand into the trolley to Santaldih PS.

Under above fact and circumstances, I, pray before you to start a specific case against the Owner & Driver of the above noted tractor having Registration number WB55B/5156 Engine No.- RMC2BBN0903 & Chassis No: MBNABACAAMRC08682, under proper section of law.
