Sir,

In producing here with 01 (One) tractor bearing registration No. JH09AD/0887 loaded with approx 2.5 MT steam coal under proper seizure. I beg to submit that today (16/06/2022) at 20:15 hrs in course of performing mobile duty at PS area vide Santaldih PS C.C No. 2701/22 dated 16.06.2022 and Santaldih PS GDE No. 657 dated 16.06.2022, I received a credible source information about illegal coal transportation from Harai Bridge side. Accordingly I informed the matter to IC Santaldih PS and as per his direction I along with force of Santaldih PS went out for executing the credible source information about illegal transportation of coal. When we reached at Paharigora More, we found that the above noted tractor is going from Harai Bridge to Dubra side. We chased the tractor but seeing the Police party from a distance the driver stopped the vehicle and fled away from the spot leaving behind the tractor. We chased him but could not able to intercept him. Then we searched the tractor and found that the tractor is loaded with steam coal. We searched for any valid documents in respect of the said tractor as well as coal loaded in it but could not find any valid documents. After finding no other alternative I seized the tractor bearing Regd. No. JH09AD/0887 loaded with approx 2.5 MT steam coal in between 20:45 hrs to 21:05 hrs, under proper seizure list in presence of witnesses duly signed by them. No public witness was available. After that we arrange for transporting the tractor from the PO and send to weigh bridge to weigh the actual quantity of coal. After that we brought the seized coal loaded tractor at Santaldih PS and kept the tractor at PS compound. Informed IC Santaldih PS and Malkhana officer. I have also seized 1 KG coal from the said seized coal loaded tractor as sample.

On secret enquiry through my reliable source it came to light that the owner and driver of the above noted tractor with their full knowledge and consent running this clandestine business by means of illegal transportation of coal for their wrongful gain.

Hence I do here by lodge this complaint with a prayer that a specific case may be started against the owner and driver of the tractor bearing registration no. JH09AD/0887 loaded with approx 2.5 MT steam coal under proper section of law and arrange for its investigation.
