I beg to submit regarding the fact of the case in brief is that today i.e on 20/06/2022 myself along with ASI Rabindranath Nag, C/662- Dhananjoy Pandey and C/1183 Subhash Kundu, all are of Santaldih I/C BCW were performing surprise Naka checking duty at Gowai bridge vide Santaldih I/C BCW GDE No. 325 dated 20/06/2022 and C.C No 514/22 dated 20/06/2022. On being asked Rabi@ Rabindranath Mahato, driver of the said motorcycle produced Registration certificate of the said motorcycle but he failed to produce any other documents in respect of the said motorcycle. Thus he committed offence U/S 279 IPC read with section 194Dof MV Act 1988 with MV (Amendment) Act, 2019.
