Sub: Prayer for starting a specific case against one Rabindranath Hembram (19 Yrs) S/o- Ramlal Hembram of Vill- Palashdanga, PS-Raniganj, Dist-Paschim Burdwan (Driver of Pickup Van having Regd. No- WB81/2682).

Respected Sir,

With due respect I ASI Madhu Mangal Bauri, beg to submit before you that on 02/06/2022 at about 17:25 hrs while myself along with force were performing evening mobile duty vide Santuri PS CC No-1631/22 Dated-02/06/2022 at Ledason More on Raghunathpur-Saltora Road (SH-8). I found one Pick up Van was coming from Raghunathpur side towards Santuri side with driving at excessive speed. Police personnel, present their in proper Police uniform raised hand and directed him to stop the Pickup Van but the said Pick up Van, violating the Police Signal and endangering human life by rash and negligently driving the Pickup Van which may cause accident to the road user any time. After long chase we can able to apprehend him at Dhekshila More. On interrogation he made incoherent statement at different time. He disclosed his identity as Rabindranath Hembram (19 Yrs) S/o- Ramlal Hembram of Vill- Palashdanga, PS-Raniganj, Dist-Paschim Burdwan. On being asked he failed to produce any valid documents of the said Pickup Van.

Hence he violated the provision of Section 279 IPC. So, I seized the Pickup Van having Regd. No- WB81/2682 at 17:45 hrs to 18:05 hrs under proper seizure list duly signed by the witnesses and arrested the offending driver namely Rabindranath Hembram (19 Yrs) S/o- Ramlal Hembram of Vill- Palashdanga, PS-Raniganj, Dist-Paschim Burdwan at 18:15 hrs avoiding by all the procedure as laid down in Cr.P.C and the latest guide lines of the Apex Court. As the offence is bailable, hence the accused driver namely Rabindranath Hembram was released on bail after furnishing proper bail bond.

So I pray before you that a specific case may kindly be registered against the accused driver namely Rabindranath Hembram (19 Yrs) S/o- Ramlal Hembram of Vill- Palashdanga, PS-Raniganj, Dist-Paschim Burdwan of Pickup Van having Regd. No- WB81/2682 for committing offence U/S-279 IPC.
