Sir,


In producing herewith one seized vehicle i.e. Tractor Swaraj 834 XM bearing Reg. Number-WB68AE/1369, fitted with Trolley loaded with sand (Approx-100 Cft.). The fact of the case in brief is that on 26/06/2022 I, SI Subrata Patra of Santuri P.S along with force was on mobile duty. During mobile duty on 26/06/2022 at about 17:05 hrs received credible source information that one Tractor is coming from Mohanpur Village side under Santuri PS loaded with sand. After receiving this information we were proceeding towards Mohanpur Village to work out the information. When we reached near Mohanpur Village, found that one Tractor is coming from Mohanpur Village side loaded with sand (Approx. 100 CFT). On seeing the Police party the driver was trying to flee away. We tried to chase him but in vain. After that we searched the said Tractor for valid documents but did not find any valid documents in respect of loaded sand in the tractor. Hence I seized the Tractor Tractor Swaraj 834 XM bearing Reg. Number-WB68AE/1369 fitted with Trolley loaded with sand under proper seizure list in presence of available witnesses duly signed by them. Thereafter I brought the said tractor to Santuri P.S. As such there is every reason to believe that the driver and owner of the Tractor Tractor Swaraj 834 XM bearing Reg. Number-WB68AE/1369 fitted with Trolley with ill motive are transporting sand illegally without any valid document in support of carrying sand. So they are liable for offence punishable U/S 379/411/414/120B IPC & 21 (1) (4) Mines and Minerals (R&D) Act-1957.

Therefore, I pray before you that a case against the driver and owner of Tractor Tractor Swaraj 834 XM bearing Reg. Number-WB68AE/1369 fitted with Trolley may kindly be started and arrange for its investigation.
