Sub: Request for lodging F.I.R. against arrested accused person namely Pappu Rawani (39 Yrs), S/o- Ramchandar Rawani of Vill- Kosogondodighi, PS- Deori, Dist- Giridih, Jharkhand.

Sir,

In producing herewith arrested accused person namely Pappu Rawani (39 Yrs), S/o- Ramchandar Rawani of Vill- Kosogondodighi, PS- Deori, Dist- Giridih, Jharkhand along with one seized vehicle (Truck) having Reg. No. AP31TH-1138.

I beg to report that today myself along with C/138 Bani Bandopadhyay and C/610 Achinta Bauri both of Tamna PS were performing day mobile duty at PS area under Tamna PS area vide Tamna PS C.C No-3366/22 dtd. 15.06.2022 and Tamna PS GDE No-653 dtd- 15.06.22 at about 12:05 hrs. while I along with force reached near Simulia Smasan Kali Mandir on Purulia-Tata road found one vehicle (Truck) bearing Registration No- AP31TH-1138 coming from Simulia Morh side rashly and negligently. We try to stop the vehicle by hand signal but the driver of the said truck named in above was trying to escape the place so rashly, there was every possibility of loss/ serious injury of nearby public due to his such driving. After chase we could able to stop the vehicle. On being asked, he stated his name and address as noted above, but unable to give any satisfactory account for his such rush and negligent driving which may cause endanger to human life. The driver also violates "No Entry" order vide Memo. No. 685/MV dtd. 03/07/19 of DM, Purulia arising out Notification No. 813-WT/3M-80/2002 dtd. 09/03/2012 of Transport Department, Govt. of West Bengal. So, I arrested him after observing all the formalities of arrest as he violated Sec. 279 IPC and 184/115/194/119/122/190 MV Act. I also seized the Truck having Reg. No. AP31TH-1138 loaded with coconut bags in presence of witnesses. His family member was also informed about the ground of arrest.

Therefore, I pray that a specific case may kindly be start against accused Pappu Rawani (39 Yrs), S/o- Ramchandar Rawani of Vill- Kosogondodighi, PS- Deori, Dist- Giridih, Jharkhand.
