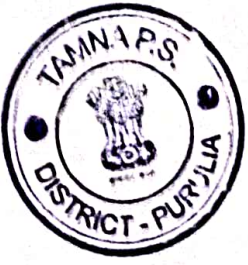

Sir,

In producing herewith arrested accused person namely Prasanta Bauri (23 Yrs), S/o- Samar Bauri of S.C. Sen Road, Bhagabandh Para, Ward No- 14, PS- Purulia Town, Dist- Purulia along with one seized black colour Honda Motor Cycle bearing Registration No-WB 56N-5712.

I beg to report that today myself along with C/138 Bani Bandopadhyay and C/610 Achinta Bauri both of Tamna PS were performing day mobile duty at PS area under Tamna PS area vide Tamna PS C.C No-3366/22 dtd. 15.06.2022 and Tamna PS GDE No-653 dtd- 15.06.22 at about 13.15 hrs. while I along with force reached near Simulia Smasan Kali Mandir I found one motor Cycle bearing Registration No- WB 56N-5712 coming from Simulia More side rashly and negligently. We try to stop him but the driver of the said motorcycle named in above was trying to escape the place so rashly, there was every possibility of loss/ serious injury of nearby public due to his such driving. After chase we could able to stop him. On being asked, he stated his name and address as noted above, but unable to give any satisfactory account for his such rush and negligent driving which may cause endanger to human life. So, I arrested him after observing all the formalities of arrest as he violated Sec. 279 IPC and 181/184/197(1)/129/194D MV Act and I also seized the motor cycle having Reg. No. WB56N-5712 in presence of witnesses. His family member was also informed about the ground of arrest.

Therefore, I pray that a specific case may kindly be start against accused Prasanta Bauri (23 Yrs), S/o- Samar Bauri of S.C. Sen Road, Bhagabandh Para, Ward No- 14, PS- Purulia Town, Dist- Purulia.
