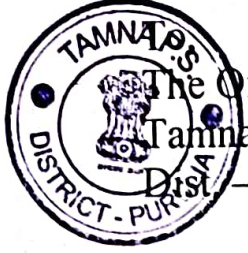

Respected Sir,

In producing herewith one arrested accused person namely Dulal Modak (35 yrs) S/O- Nemai Modak of Vill- Chakaltore, P.S- Tamna, Dist.- Purulia with seizure list and seized articles, I beg to submit that today i.e on 17.06.2022 at about 18:45 hrs during PS evening mobile duty, received a secret source information and as per order of O/C Tamna PS, I SI Nikhil Pratap Singh of Tamna PS along with force had been to Chakaltore under Tamna PS at 19:05 hrs and as per indication conducted raid in the shop of Dulal Modak (Dulal Electrics and Mobiles) and detained one person. On asking his identity he disclosed his identity as noted above. On interrogation he confessed his guilt for selling and possession Liquor. On demand he failed to produce any valid documents in respect of stock and selling of said Liquor in the shop of Dulal Modak. As such I seized (i) Eleven (11) bottles Officers Choice Delux Whisky Net Qty- 180 ml each, M.R.P- 130 each, (ii) Six (06) bottles Mc Dowells No- 1 each Qty- 180 ml each, M.R.P- 140 each & (iii) Twenty (20) liters illicit liquor in one plastic jarican (colour white) taken one Bottle Officer Choice and One bottle Mc Dowells No- 1 and one liter illicit liquor from jarican as a sample under proper Seizure List. in presence of witnesses duly signed by witnesses and accused person. Total Qty- 23 Liter 60 ml Arrested the above noted accused person after observing all legal formalities regarding arrest. Informed him the ground of his arrest. The seized articles were properly sealed and label in presence of witnesses duly signed by them and accused person.

The above noted accused person namely Dulal Modak (35 yrs) S/O- Nemai Modak of Vill- Chakaltore, P.S- Tamna, Dist.- Purulia committed offence u/s- 46 A(c) B.E. Act- 1909 for unauthorized possession and sales of ID Liquor from his house.

Under the fact and circumstances kindly take necessary lawful action against Dulal Modak (35 yrs) S/O- Nemai Modak of Vill- Chakaltore, P.S- Tamna, Dist.- Purulia.
